

# Home Resales Fund Continues Upward Trend

The number of home resales and the corresponding contributions to the Resales Improvement Fund (RIF) collected yearly continues its upward climb.

In 2017, Leisure World’s 29 mutuals completed 421 total home resales that aggregated \$1,602,968.22 for the RIF, an increase of approximately \$24,571 from 2016, and an increase of more than \$85,000 from 2015’s collection.

The total number of home resales also jumped slightly this year, with eight more completed than in 2016.

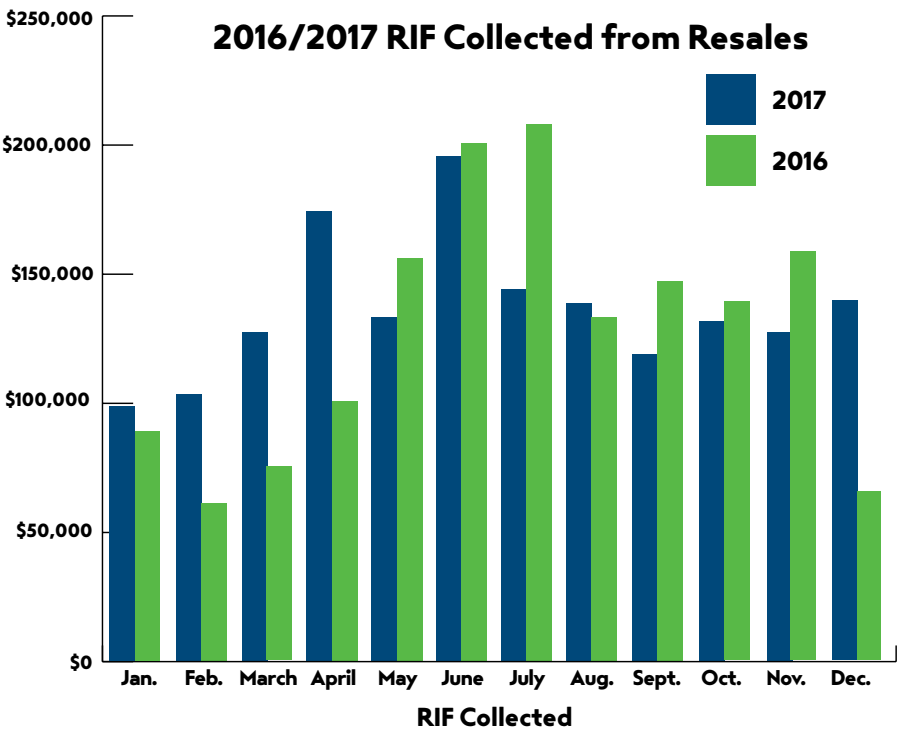
Monthly resales peaked in June at 44 total for the month,

with April a close second at 41. October and December each had the third most monthly resales, with 40 each.

RIF reserve monies are designated for the improvement and expansion of the Trust as outlined in Leisure World of Maryland Corporation’s Trust Agreements, documents that explain how mutuals’ individual association fees fund the maintenance and management of individual Trust properties.

Two percent of the gross sales price of each home resale is deposited into the RIF, also sometimes referred to simply as the Resales Fund, and is used to endow Trust properties, such as the Administration

# Committee Looks Ahead to Community’s Future, Seeks to Hire Strategic Planning Consultant

To achieve its goal of planning for Leisure World’s future, the Special Strategic Planning Committee (SSPC) is considering hiring an external consultant to better understand the community’s demographics.

“We don’t know what people want because we don’t know who is living here or what their goals are,” said Dr. Richard Fisher, SSPC chairman, adding that the committee also has “to know what appeals to people outside; what people are looking for in the community.”

The consultant would help conduct a demographic study of the community and analyze current conditions and trends affecting Leisure World and competing age-restricted communities.

The committee and consultant would work together to engage residents in the strategic planning process and gather input and feedback from community members during several open forums.

The consultant would then draft a five-, 10- or 15-year strategic plan to be presented to the Leisure World Community

## Spotlight on... Bid Whist

# From Silver Spring to Boston in One Night

**O**n most Monday evenings, members of a group of residents make plans to “rise and fly” and go uptown – or downtown, for that matter – or maybe even to Boston.

To do that, they meet in Clubhouse II, where they spend a couple of hours engaged in lively games of bid whist.

A three-centuries-old forerunner of bridge, whist is a trick-taking game of poker-like strategy and communication between two sets of partners around a card table. A deck of cards is dealt among them, a trump suit is determined, and in each trick a player leads with

a card whose suit is matched by the other three players.

There’s more to the game, of course, especially when the basic game, or “straight whist,” includes advance bidding on the number of tricks a team predicts it will win in a game – in that case, “bid whist.”

Sometimes, newcomers who are learning the game and its lingo might feel a little intimidated, says Joe Powell, a regular to the weekly games. “But you learn as you play,” he adds. “Once they get the flow of it, they’ll stick out their neck and bid.”

Players can pick up the lingo of the game as quickly as a player’s hand sweeping across the table to collect a winning trick. Placing

a high bid is going uptown, while a low bid is downtown. Sporting the kitty might be helpful, but it’s not good to have to rise and fly, which might happen if you’ve lost a rubber hand. Getting to Boston, however, is cause for a team to celebrate.

Leanna Gibson, another regular, found learning whist to be easy decades ago, after learning all kinds of card games from her parents. “I was a card shark by the time I was nine,” she says with a broad smile.

Jessie Fitzpatrick, who organizes the games, started playing when she was married and her husband was away on military maneuvers. The military wives would get together, and “we would play practically all night,”

she recalls.

Amid the rattling of shuffling decks of cards, the clapping of cards on the tables, and the crinkling of Fritos bags, players add their own vocal swagger to the friendly competition.

“You can talk trash, and get your opponent all rattled,” Fitzpatrick says with a sly wink. “That’s part of the game.”

Nevertheless, the emphasis is on “friendly” regarding bid whist competition. Soon after, she stood next to a table of players and excitedly announced to the room: “Joe got a Boston!” to an eruption of cheers all around.

Corporation (LWCC) board of directors for their recommendations or approval.

Hiring an external consultant is estimated to cost approximately \$125,000, according to the committee's report that was presented at the November LWCC board of directors meeting.

The board subsequently directed the SSPC to engage with residents to explain and receive feedback on the committee's goals and processes.

The SSPC plans to speak to advisory committees and hold information sessions for residents in the coming months, then report on the results of the sessions and recommend a course of action at the board's March meeting.

Since its initial meeting in May 2017, the SSPC has met with four external consultants with expertise in strategic planning for communities similar to Leisure World, to learn about the strategic planning process and help the committee decide on a course of action.

The committee has also examined various types of strategic planning and best practices used

in other community associations and considered ways those ideas may be relevant to Leisure World.

In April 2017, the SSPC was tasked by the board of directors with developing a long-range strategic plan to address Trust facility upgrades, infrastructure, organizational support and financial requirements and recommended steps for implementing the plan.

The SSPC recognizes that a sound financial investment, desirable quality of life and personal security and safety are three valued elements of life at Leisure World that are of particular interest to the majority of its residents, Fisher said. The committee is focused on determining how best to achieve and sustain these prized elements of the community.

Fisher, a scientist with NASA for 25 years before retiring in 2012, administrated the strategic planning for "about a quarter of NASA science" in 2000 and again in 2010. He said that all five SSPC members have experience in some form of strategic planning for government, academic or other organizational entities.

In addition to sharing information on how residents can be generally vigilant in keeping their homes and themselves safe, panelists can address questions and concerns that have arisen among some residents regarding recent law enforcement arrests that took place in the community.

In mid-December, police served a warrant on a resident who is a registered sex offender and took him into custody. He remains incarcerated and is awaiting trial.

# Jan. 24: 'Technological Advances in Genetics and Genomics'

It seems that not a week goes by without a published article detailing how DNA and genetics help to predict and prevent many health issues from becoming major concerns.

The Center for Lifelong Learning (CLL) presents Dr. Kimberly Jacoby Morris' discussion, "DNA Is Here To Stay: Technological Advances in Genetics and Genomics." The presentation is on Monday, Jan. 29, at 2 p.m. in Clubhouse I.

Jacoby Morris's presentation focuses on the technological advances in the field of genetics and genomics. She presents a brief overview of DNA structure and function, followed by a discussion of how genetics and genomics affect biomedicine today.

Topics of genetic sequencing, genetic cloning and gene editing are highlighted.

Jacoby Morris is a current postdoctoral fellow at the National Institutes of Health (NIH) in the National Institute of Biomedical Imaging and Bioengineering laboratory of Dr. George H. Patterson.

Her current projects focus on developing fluorescent proteins for imaging technologies.

Prior to her arrival at NIH,

Jacoby Morris was an interim organic chemistry laboratory lecturer at Bryn Mawr College

in Pennsylvania. She received her doctorate from Temple University in Philadelphia for her contributions in understanding the chemical mechanisms of UV-damaged DNA repair.

Passionate about science education, Jacoby Morris obtained a detail appointment in the Education and Community Involvement Branch of NIH's National Human Genome Research Institute.

As people age, many regard DNA as an attractive means of learning more about someone's ancestry and heritability.

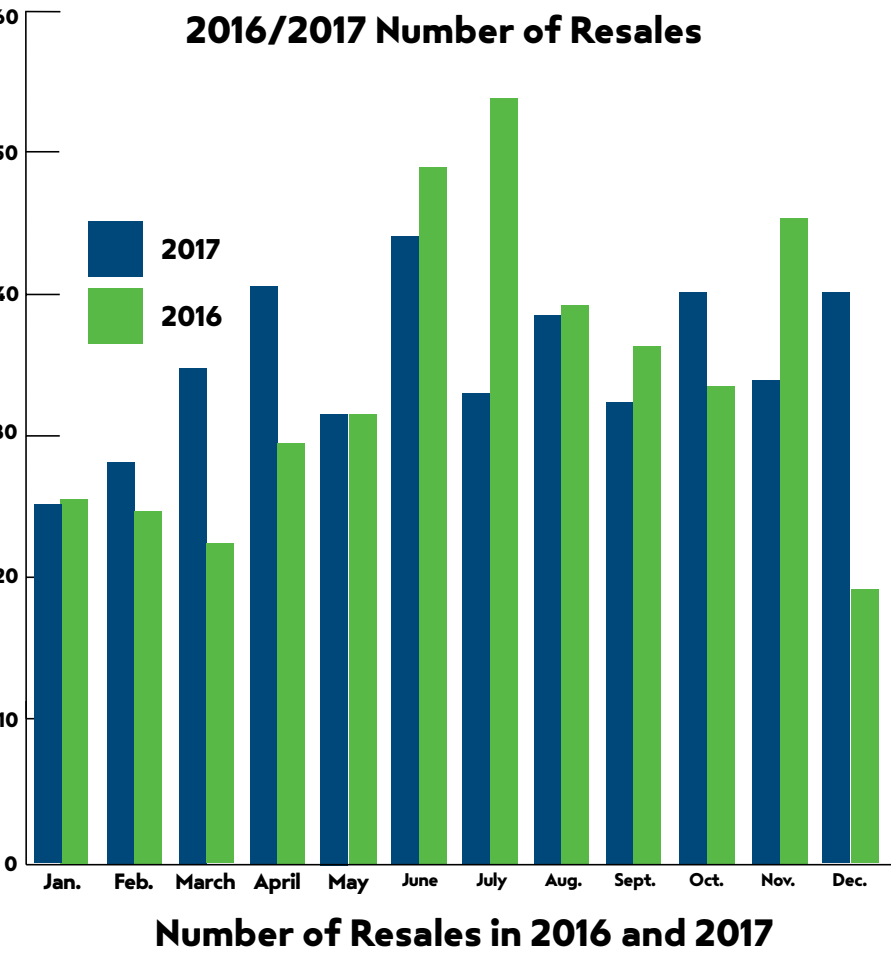

# Staying Steady in Ice, Snow and Sleet

When winter weather strikes, residents may consider arranging their schedules to coincide with Leisure World’s snow removal plan.

Even after streets and pathways have been dug out, going out in wintry conditions can still be a challenge. The January 2018 issue of Consumer Reports on Health has the following suggestions for getting around when individuals must go outside.

- Exercise; stronger muscles reduce the likelihood of falls by improving balance.
- Wear the right shoes. Deeply grooved, nonskid rubber treads can help to avoid slips and trips on the ice and snow. Wear lace-up shoes that fit snugly. Consider adding traction with slip-on ice cleats,

- available at sporting goods stores. In a pinch, try wearing a pair of socks on the outside of shoes.
- When returning indoors, take off wet shoes and change into a pair of dry shoes to keep steadier on your feet.
- If you must walk over snow or ice, take short, flat steps, like a penguin.
- If you must climb stairs, face the railing, hold on with both hands and step sideways.
- If you use a cane or walker, consider adding an ice-gripping tip to the bottom.
- If you must go outside to your car, salt the path from your door. Consider carrying a bag filled with some kitty litter to sprinkle on any slick surfaces wherever you go.
- Keep eyeglass prescription up-to-date and make sure you can see where you are walking.

# 2018 Swimming Pool and Fitness Center Rules and Regulations

**Rules Applying to ALL Pools:**

1. Only residents and their guests may use the pool. Upon presentation of a season pass or appropriate ticket, pool staff must sign in residents and accompanied guests. Residents are responsible for guest conduct. Admission tickets are available daily in the E&R offices during regular business hours. Proper identification is required, and prices are listed at the end of these rules.
2. Guests may use the pool only after 10 a.m. Children may swim from 10 a.m.-1 p.m.
3. Children ages 4-16 must be accompanied by an adult and wear swim attire at all times. Children under age 4 are not permitted on pool decks or in pool areas. A child using any flotation device must have an adult within arm's reach at all times.
4. Showering before entering pools is required.
5. Persons having excessive sunburn, open sores or bandages of any kind will not be allowed to enter the pool area.
6. Deck chairs and lounges may not be reserved nor brought from outside the pool area. Chairs and lounges must not block the periphery of the pool.
7. Pets, food, chewing gum or drinks are not allowed on pool decks or in pool areas. Refer to E&R Clubhouse Rules and Regulations regarding allowance of

- service animals.
8. Lifeguards and E&R staff are not responsible for personal property.
9. The lifeguard and/or E&R staff manager on duty may limit the number of people in the pool and pool area.
10. Flippers, noodles and boards are permitted at the discretion of the lifeguard on duty.
11. The lifeguard on duty will arbitrate problems that may develop. Horseplay is prohibited. Hanging on the ropes is not permitted.
12. The E&R staff will schedule structured activities.
13. Individuals who require assistance preparing to use or access the swimming pools must arrange to have a competent, water safe person accompany and help them in the locker rooms and pool area.
14. All individuals in the pool area must be in bathing attire. Street shoes are not permitted on the pool deck. Soft-soled footwear is acceptable if not worn as street shoes. Bathing attire must be appropriately covered in the clubhouses.
15. All applicable Montgomery County Department of Recreation swimming pool rules and regulations are in effect.

**Outdoor Pool**

1. Outdoor pool and locker rooms are open daily

Memorial Day to Labor Day, 10 a.m.-7 p.m. Monday through Friday; 10 a.m.-7 p.m. Saturday and Sunday; then on a weekly basis in September, weather permitting. The pool closes on July 4, Independence Day, at 6 p.m. (Hours are subject to change; watch channel 974 for information.)

1. First Sunday rule: Children are allowed to swim from 10 a.m.-3 p.m.
2. All debris must be placed in proper receptacles in the pool area.
3. Fun noodles are not permitted in the lap lane.

**Indoor Pools**

1. Indoor pools are open Monday, noon-7 p.m.; Tuesday through Friday; 8 a.m.-7 p.m.; and Saturday and Sunday, 8 a.m.-6 p.m. (Hours are subject to change; watch channel 972 for information.) The pools are closed on Thanksgiving, Christmas Day, and New Year's Day.
2. Children ages 4-12 may use the social pool only, from 10 a.m.-1 p.m. daily, and Saturday and Sunday until 3 p.m. Children ages 13-16 may use the lap pool between 10 a.m.-1 p.m.
3. Those who use the whirlpool must have a pool ticket, sign a "Whirlpool Agreement" form, available at both clubhouse E&R offices and sign in.
4. Designated lockers may be rented each calendar year for \$35, women's full size

lockers for \$55, and men's full size for \$65. Information is available in the E&R office in Clubhouse II. Private locks are permitted. Lockers used daily must have locks removed at closing time.

**Fitness Center**

1. Those wishing to use the exercise equipment must complete a "Fitness Facility Use Agreement" form and sign in and out.
2. Guests must be 18 years or older and be accompanied by a resident.
3. There is a time limit of 30 minutes on cardio equipment when others are waiting.
4. Proper shoes must be worn.
5. Equipment should be wiped down after use.
6. Cell phone use is prohibited.

## New Administration Building and Accessibility

On the various email lists here in Leisure World, I have seen a new alternative to constructing a new Administration Building and demolishing the existing structure, which was developed by one of our fellow residents. The idea is to leave the existing Administration Building “as is” and the new construction would be a “Clubhouse III,” for the benefit of the residents. Additional space for staff would be provided by the vacated space in Clubhouse I. There would be several entrances to the new building so that each would provide at-grade access, no matter where one parked in the existing parking lot, and of course, no stairs. I think the idea has merit, and, according to the email lists, others do too. If we can avoid tons of debris from demolition and the downing of close to 60 adult trees, I think that would be a great idea.

However, I’m sure there are more alternatives, if we just open our minds to them.

How about adding a lower level to the Clubhouse I lanai, starting from the woodshop around the pool to the Chesapeake room? Parking would also be extended from the wood shop all the way around to the Chesapeake room. This would give at-grade access to the pool level and there would be an elevator up to the restaurant level. That would eliminate the need for a new building and would prevent the cutting down of adult trees.

## Alternatives for Administration Building Project

As a former resident of one of Georgetown’s “old” townhouses – circa early 1800s – I can appreciate what happens to those soundly built structures of yesteryear. Still,

razing the entire building to provide more level parking and office space seems far too drastic – and expensive. My own house was pretty much gutted and rebuilt on an open plan. From the outside, it retains its original character.

As a former member and chair of the Montgomery County Historic Commission, I remember that, in our view, razing was the last resort. We always tried to preserve historic appearances of buildings, for example, the old hardware store in Bethesda and many other sites.

Several alternatives to the present plan have been suggested, all of which seem a lot more sensible. I particularly like the town hall meetings idea, especially for something like this radical revision of Leisure World’s appearance. Were any independent alternative studies done? Like how to make use of the existing structure? Level parts of the parking lot? Hire a valet service to operate at peak usage times? Or even a second story on the gutted building – with elevator of course.

Leisure World has become a “downsize” community for many who are still working and intend to keep working. Daytime meetings are useless for a good many residents who are consequently not in the planning loop. The result is what we have – a limited number of people who are doing their best to decide without much expert input or resident consensus. In my opinion, that mixture can hardly lead to the best solution.

## Misleading LW News Article

I am sorry to have to say this, but I feel that the article “Project’s Site Plan Revised, Mutuals to Receive Updated Version” published in the Dec. 15, 2017 edition of Leisure World News is misleading and must be corrected if the residents of Leisure World are to know what is really happening.

Commissioner Cichy advised, “Have better discussions and consensus,” and Commissioner Fani-Gonzalez said, “Talk to the people who live there and make consensus.”

Planning Board Chair Casey Anderson said that the project was “not well considered.”

Commissioner Cichy believed that the project was “not meeting the needs of the

residents” who are paying the bills.

Commissioner Fani-Gonzalez, who made the motion to defer, gave two reasons, not just one as indicated in the Leisure World News article. The most important was, she said, “It’s just bad that you don’t have your community behind you. It’s your job to make sure you have engagement” and “You can’t just check off the box.”

In my opinion, the Leisure World News article gives the impression that the Planning Board was generally favorable to

the current plan. I believe that nothing could be further from the truth.

The Planning Board wants real discussions with residents and a thorough consideration of alternatives. (One alternative might be to change the new Administration Building to a new Clubhouse III for the benefit of Leisure World residents).

Some may say it is too late to consider additional alternatives. In my opinion, this is

absolutely false. The Planning Board has not approved the current plan and is not likely to do so for months, if at all. While money has been spent on the current design, the Leisure World Community Corporation (LWCC) board of directors has changed its mind many times before finally approving it. With each change additional costs were incurred, so one more change of mind – especially if it brings peace to our commu-

nity – is exactly what I believe is needed now.

I feel, and the Planning Board made it clear that they agree, that the important thing is to meet the needs of the residents – structurally, environmentally and financially.

Will the LWCC board listen to the recommendations of the Planning Board to engage with Leisure World residents and achieve consensus? I hope so.

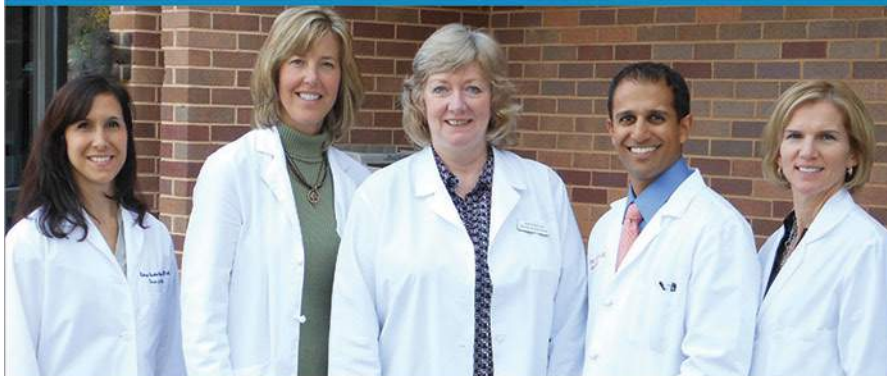

The church begins to hesitantly welcome Burmese refugee farmers. The congrega-

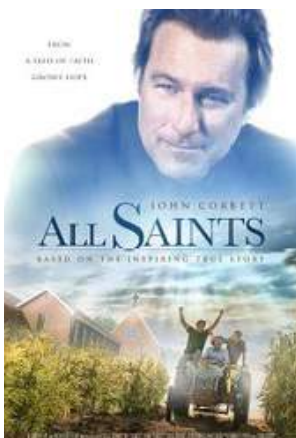
tion attempts to turn their land into a fertile farm to pay the church's bills and feed its newest people. The pastor must choose between his assignment to sell the property or the

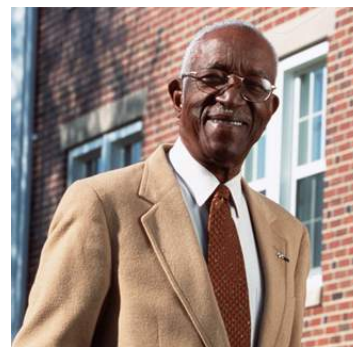

# Second-hand Smoke – a Dangerous Health Hazard

**W**hen some residents were growing up, many people smoked cigarettes. But even if a person didn't smoke, they were frequently exposed to smoke from those smoking around them.

Today, smoking is banned in most public places, including some public parks in Montgomery County. Exposure to second-hand smoke is just as dangerous as smoking. Now, unless a person is around someone who is smoking outside, exposure to second-hand smoking in public areas is minimal.

However, that is not the case for people who live in an apartment that shares a wall, floor, hallway or ceiling with another unit where a smoker lives. Some smoke filters into the surrounding apartments.

Respiratory problems, such as asthma or chronic obstructive pulmonary disease, may be exacerbated by exposure to second-hand smoke. But second-hand smoke is a health hazard for everyone.

According to the Centers for Disease Control (CDC), second-hand smoke is a contributing factor in approximately 41,000 deaths in the U.S. among non-smoking adults. Second-hand smoke can cause lung cancer, strokes and heart attacks. Therefore, for optimal health, it's best to avoid all exposure to second-hand smoke.

At least one condo association in Leisure World is exploring the possibility of having a smoke-free building, which would prohibit smoking in individual units.

The CDC and the American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) both claim it's impossible to remove second-hand smoke by improving ventilation or installing air cleaners. The only way to eliminate indoor second-hand smoke is to ban

indoor smoking.

Condominium or homeowners associations have the authority to prohibit smoking in individual units so long as such regulation does not violate the bylaws of the particular association, according to the Office of Counsel to the General Assembly of the Attorney General of Maryland.

In that case, the bylaws would have to be amended; but if that were done, Maryland law does not prohibit a condo or homeowners association from prohibiting smoking in individual units.

"A tenant or homeowner who is repeatedly subjected to unwanted smoke drift from neighboring units may have viable grounds to seek an injunction and reimbursement of related costs against both the smoking neighbor, management, and the homeowner's association," according to Brooke Torton, JD, of the Legal Resource Center for Public Health Policy at the University of Maryland Francis King Carey School of Law.

Such claims are frequently justified by the common law concept of "nuisance." According to Torton, "nuisance is defined as anything that works or causes injury, damage, hurt, inconvenience, annoyance, or discomfort to one in the legitimate enjoyment of his reasonable rights of property, or which renders ordinary use and occupation by a person of his property uncomfortable to him."

If a resident of a condo or homeowners association were to sue because of second-hand smoke infiltrating his/her unit from an adjacent apartment, that would mean that the condo or homeowners association and the resident of the unit where the smoke originated possibly would incur legal costs and liability for a settlement.

Preventing second-hand smoke exposure from adjoining apartments may be a way of avoiding legal jeopardy and possibly a fire, in addition to promoting good health.

Smoke-free dwellings are in high demand across the U.S., according to the Oklahoma State Department of Health's Website. The University of Maryland Law School has a list of over 60 multi-unit buildings in Maryland that are currently smoke-free.

Smoking is not a right that is protected by any law, according to Torton. More importantly, smoking is extremely harmful to the smoker's health. This is likely to be especially true for Leisure World residents, who

are older and may have been smoking for many years.

The most important change smokers can make to improve their health is to stop smoking. It is hard for a long-time smoker to stop, but it can be done. Modern smoking cessation treatments have a much higher rate of success than previously. The Health Advisory Committee is working to make smoking cessation treatment available at the MedStar Health medical center.



# 'Reverend Martin Luther King Jr.; In His Own Words' Class Explores Key King Documents

Through his speeches and actions, Rev. Dr. Martin Luther King Jr. helped shape the America of the second half of the 20th century, and the impact of his work continues to pervade the American psyche and the events of the 21st century.

Among King's many writings and speeches three stand out as being particularly profound: his April 16, 1963 "Letter from a Birmingham Jail," in which he sets out his rationale/moral purpose for his actions in Birmingham; his Aug. 28, 1963 "I Have a Dream" speech at the March on Washington for Jobs and Freedom; and the April 4, 1967 address he delivered at Riverside Church in New York City, in which he came out against the Vietnam War.

Resident Paul Levy has a particular fascination with

history and historic people, and is interested in reintroducing residents to these three documents, as well as to the times in which they were produced. He will do so in a course sponsored by CLL entitled "Reverend Martin Luther King, Jr.; In His Own Words."

Levy leads the class in rediscovering the full content of these pieces. Moreover, since over a half century has passed, he will be operating on the assumption that the class will need to talk about the context in which each of these pieces were produced in order to fully appreciate their content and to recall the significance of the times.

Levy has taught several fascinating courses for CLL, some of which have focused on issues related to civil rights. His

classes are lively and exciting, and all ideas are encouraged and welcomed during class discussion. He provides copies of the three documents during the first class, with the expectation that participants read material in advance of the subsequent classes.

Levy holds a Bachelor of Arts in political science from the University of Massachusetts (Amherst), and master's and doctorate degrees in education. He was a teacher and administrator in public schools for 41 years, taught at a community college, and was a visiting associate professor at Temple University.

During his career, Levy taught American history, European history, economics, civics and psychology. He has also given courses on civil rights

and related topics at the Bender Jewish Community Center of Greater Washington and at other venues in this area.

# Fluvial Geography: Rivers of the World

Over the past several years, resident Tom Conger has presented a number of courses that take residents on adventures that look at history, politics and culture from a geographical perspective.

Conger returns with a new CLL course that examines history and economics from the perspectives of the world's rivers. He posits that humans take rivers for granted.

Rivers have been, and continue to be, very important to human existence. Just consider that rivers attracted human habitations long before the dawn of recorded history.

Early civilizations arose in the period 4,000 to 2,000 B.C. in, for example, alluvial valleys of the Nile River in Egypt, the Indus River in what is now Pakistan, and the Yellow River in China.

Today, rivers continue to be the focal point of numerous

cities and towns – think about the Mississippi, the Hudson (which is not really a river, but an estuary), and the Ganges.

Rivers are integral to the U.S. economy and have an immense amount of wild-life that lives in, on or near them.

Conger's interest in geography can be traced back to his father, who was also fascinated by the topic. Conger received a Bachelor of Science in geography from the University of Georgia and a Master of Arts in the subject from the University of Cincinnati.

While in Cincinnati, Conger also received a master's

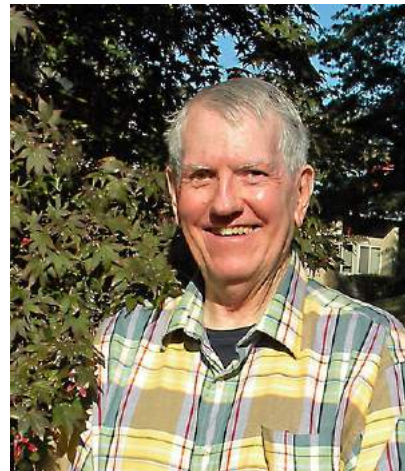
degree in city planning. He worked as a city planner for 12 years and then ran a small life insurance company for 20 years.

Subsequently, while living in Flagstaff, Arizona, Conger taught earth science in public schools and various geography courses at Northern Arizona University.

# Heliophysics: A New Scientific Discipline for the Space Exploration Era

**H**eliophysics is the study of the sun and how it influences the space around it. While a relatively new discipline that arose from the fusion of astrophysics and metrology, heliophysics is a rapidly developing field of science enabled by modern spaceflight and access to space.

Heliophysics is now an important component of the NASA's research program. The basis of heliophysics is that the sun's atmosphere extends far out into the solar system and influences the Earth and all other planets.

Leisure World is fortunate to have as a resident one of NASA's pioneering experts in heliophysics, Dr. Richard Fisher, who will teach a course on the subject sponsored by the Center for Lifelong Learning (CLL).

Heliophysics research provides new cultural and intellectual knowledge, and also provides political and economic benefits to support modern life and society. Its goal is to understand the nature of stars and space and use this knowledge to support human efforts of living and working in space.

While the study of heliophysics sounds formidable, many of the facts were either unknown or unobserved until the dawn of the Space Age.

Fisher's course on heliophysics includes discussions of the sun, the heliosphere, Earth's magnetosphere, space missions to study the heliosphere and modern space weather. Fisher will share not only knowledge about the

topic, but also his own experiences as an astrophysicist and astronomer.

Fisher has been a Leisure World resident for the past eight years. He retired from NASA in 2012, but continues as scientist emeritus at the Goddard Space Flight Center. Born in Wichita, Kansas, he received his undergraduate degree from Grinnell College in Iowa and his doctorate in astrogeophysics from the University of Colorado.

Fisher was the first Director of the Heliophysics Division of NASA. Over the past 25 years, Fisher has been awarded NASA's Distinguished Service Medal, the NASA Exceptional Achievement Medal, the NASA Exceptional Service Medal, the

NASA Outstanding Leadership Medal, and the Presidential Rank Award of the Senior Executive Service.

# Jan. 11: Rep. Jamie Raskin Speaks at Meeting

Rep. Jamie Raskin speaks at the Democratic Club's Thursday, Jan. 11, meeting at 7 p.m. in Clubhouse I.

He serves on several Congressional committees and has become a key member of several Democratic caucuses.

In 2016, Raskin ran for the U.S. House of Representatives in a crowded, seven-way Democratic race, which he won with 33 percent of the vote.

In the general election, he won against the Republican candidate with 60 percent of the vote.

In 2006, Raskin was elected to the Maryland State Senate for District 20 (just south of Leisure World's District 19).

He served 10 years in the Maryland Senate.

He was a strong proponent for liberal issues in the Maryland Senate, advocating for

same-sex marriage and the repeal of the death penalty, and establishing legal guidelines for Benefit Corporations.

Politics seems to run in Raskin's family. His father, Marcus Raskin, was a staff aide to John F. Kennedy, and his wife, Sarah Bloom Raskin, served as the U.S. Deputy Secretary of the Treasury during the Obama administration.

A graduate of Harvard University and Harvard Law School, Raskin is a former professor of constitutional law and legislation at American University.

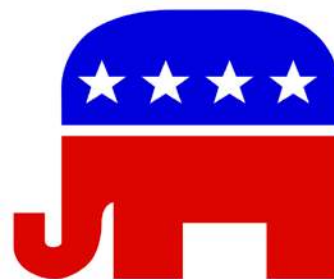

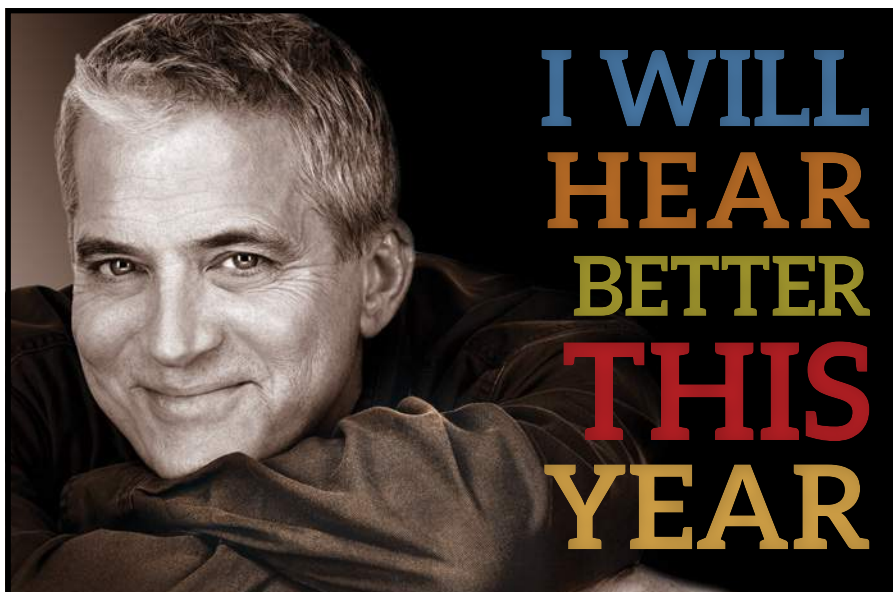

# iOS Control Center

Most people only use a tiny fraction of the iPhone and iPad's capabilities, but becoming more familiar with iOS devices and their features can fix that.

Control Center is the one-stop place to control the features on the device. Call up the Control Center by swiping up from the bottom of the screen.

The iOS 11 is a friendlier operating system that makes it easier to manage devices for an improved user experience. It looks a little different on the iPhone than on the iPad, because the iPad has a bigger screen and displays more information.

The Control Center typically contains toggles for Wi-Fi, Bluetooth, Airplane Mode, Flashlight, Media controls, Brightness, Volume, Rotation Lock, Do Not Disturb and AirPlay.

Users can add many more,

such as Accessibility Shortcuts, Alarm, Apple TV Remote, Calculator, Camera, Do Not Disturb While Driving, Guided Access, Home, Low Power Mode, Magnifier, Notes, Screen Recording, Stopwatch, Text Size, Timer, Voice Memos and Wallet.



## Adding/Removing from Control Center

Users can add or remove items according to their needs. Go to "Settings">"Control Center">"Customize Controls," which reveals how to "Add and organize additional controls to appear in Control Center."

The "included" shows all items currently in the Control Center. Scroll down to see "more controls," which can be added. Tap the green circle to add or the red circle to remove an item from the Control Center. To confirm changes, swipe up from the bottom of the screen and have a look.



For example, to add Camera to the Control Center, swipe up to open the Control Center, tap the Camera icon, and it's ready to shoot. By touching and holding the Camera icon, the user is immediately given four options: Take Selfie, Record

Video, Record Slo-mo or Take Photo, which eliminates the need to make these selections in the camera itself.

“Necessity is the mother of all invention,” or so the proverb goes.

But boredom can also spark a novel idea, something Washington state Rep. Joel Pritchard discovered in the summer of 1965 during a particularly humdrum visit to his friend Bill Bell’s home on Bainbridge Island just outside Seattle.

The two were looking for a way to pass the time together with their families on the property’s old badminton court, but couldn’t find a full set of racquets to play with.

Instead they played with ping-pong paddles and a perforated plastic ball, lowering the 60-inch badminton net to 36 inches to accommodate the height of the ball’s bounce against the asphalt.

The following weekend, they introduced their friend Barney McCallum to the improvised sport, and suddenly the three men were devising rules together.

In 1972, a corporation was formed to protect the new racquet sport – pickleball – and its popularity grew in the Seattle area, where it was used in high school and college physical education programs.

Today, pickleball has become an increasingly popular sport among older adults, with the USA Pickleball Association reporting that more than 66 percent of its members are age 60 or older.

# For Whom the Ball Drops

At 11:59 p.m. on New Year's Eve, the ball begins to drop at Times Square in New York City. Millions witness the descent on the streets or on television. It is a celebration of the passage of time, with expectations of a better year to come and resolutions to make that happen.

The ball has become a symbol of the holiday. It is now in public view year-round atop the building at One Times Square. The ball has been dropping each year since 1907 (except for the War years, 1942-43).

Times Square celebrations started in 1904, when Adolph Ochs (owner of the New York Times) purchased the building for the newspaper's new headquarters. At the time, the building was the tallest in Manhattan if measured from the bottom of its four massive sub-basements, built to support

the heavy printing equipment.

Originally known as Longacre Square, Ochs successfully lobbied the City to change the name to Times Square. Around the same time, August Belmont, president of the Interborough Rapid Transit Company, suggested the name change, as the city opened its first subway line.

The first New Year's Eve celebration followed an all-day street festival with fireworks set off at the base of the tower at midnight. According to the New York Times, "the joyful sound of cheering, rattles, and noise-makers from the over 200,000 attendees could be heard... from as far away as Croton-on-Hudson, 30 miles north along the Hudson River."

Thus, Times Square replaced Lower Manhattan's Trinity Church as the focal point of New York's New Year's celebration. Two years later, when the city banned the fireworks display, Ochs arranged to have an illuminated iron and wood

ball lowered from the tower flagpole precisely at midnight to signal the beginning of 1908. The ball was five feet in diameter, weighed 700 pounds, and was illuminated by one hundred 25-watt light bulbs.

The nature of the ball has changed over the years. In 1920, a 400-pound ball made entirely of wrought iron replaced the original. In 1955, an aluminum ball weighing only 150 pounds replaced the iron ball.

This aluminum ball remained unchanged until the 1980s. During the "I Love New York" marketing campaign (1981-88) the ball was made to look like an apple with red light bulbs and a green stem. The traditional white ball returned in 1989 without the green stem. In 1995, the ball was upgraded with aluminum skin, rhine-



stones, strobes and computer controls.

To ring in the year 2000, the ball was completely redesigned by Waterford Crystal and Philips Lighting. The crystal ball combined the latest in lighting technology with the most traditional of materials to celebrate the new millennium.

In 2007, for the 100th anniversary of the ball drop tradition, a new LED crystal ball was designed, replacing the incandescent and halogen bulbs of the past century. The ball, now 12 feet in diameter and weighing nearly 12,000 pounds, is adorned with 2,688 Waterford Crystal triangles, illuminated by 32,256 Philips Luxeon LEDs (light emitting diodes), greatly increasing its brightness and color capabilities.

It is now a permanent feature of the building at One Times Square. Predictably, chess players at Leisure World resolve to play better next year. They do not need a holiday or a big celebration to play. In the game pictured on this page, Black's Queen has just captured a Pawn at c5. What is White's best move?

The answer follows the reminder that the Chess Club meets on Monday, Wednesday and Friday from 1-4 p.m. in Clubhouse II. For further information, call Bernie Ascher at (301-598-8577).

ANSWER: White moves the Pawn to f7. Checkmate!

So, do not wait for a spectacular celebration. Do not wait for a ball to drop. Do not wait until next year. Play chess now!
