## Board Defeats Proposed Referendum on New Building

The Leisure World Community Corporation (LWCC) board of directors firmly voted down a motion calling for a general vote by the community ownership for a direct decision to affirm or deny the construction of a new Administration Building.

"If we vote to approve this motion, it sets a precedent," said board member Linda Wach at the board's May 23 meeting. "What this [resolution] does is to take away the governing authority of this board if it were in fact approved."

Board member Bob Tropp echoed Wach's sentiments. "We have a representative type of government, and this [resolution] really goes to the very heart of a challenge to that," he said.

Petitions calling for a community-wide referendum on the construction project were collected by a group of concerned residents in May.

The motion the board voted on at its May 23 meeting targeted the proposed new Administration Building only.

The Administration Building and Clubhouse I Site Improvements project includes the construction of a new Administration Building and site improvements to Clubhouse I, including modifications to parking, land-

scaping and walkways, and the construction of vestibules for the Terrace Room and Clubhouse Grille.

LWCC is currently estimated to expend just over \$7.2 million of Resales Fund money on the project. A site plan for the project was submitted to the Maryland-National Capital Park and Planning Commission May 15.

A design team is reviewing cost benefits for solar installation on the building, said Kevin Flannery, Leisure World general manager.

Flannery provided the board with updates on other Facilities Enhancement Plan projects, including the Fitness Center, which is scheduled for exterior wall construction later this month.

### Finances

Year-to-date, LWCC has an operating deficit just shy of \$25,000. Flannery cautioned that the deficit reflects a \$46,000 rental income loss in the administrative department over the past four months due to the absence of a tenant in the building's bank space.

Signal Financial Federal Credit Union has entered into a lease with the community, with a Tuesday, Aug. 1 target opening date for customers.

A total of 41 property transfers in April generated

## First Female Vet to Lead July 4 Parade

When the open convertible rounds the corner onto Leisure World Boulevard on Tuesday, July 4, seated in its place of honor will be the first female parade grand marshal at Leisure World.

Barbara McCool, a retired lieutenant colonel in the Air Force Reserve Nurse Corps, deployed during Operation Desert Storm, serving as Acting Commander for the 22nd Aerial Port Squadron (APS) at a small, tactical base in Torrejón, Spain.

She and the 10 other APS members sent from Andrews

Air Force Base augmented the newly created 401st Aeromedical Staging Facility (ASF), a 250-bed hangar designed for patients to deplane C-130 Hercules aircraft for emergency medical care.

"I went in as a nurse with quite a bit of experience, experience that I could share with a lot of people, and I could mentor a lot of people. And my mission was very clear: I wanted to be the best officer, the best nurse, as I could."

As assistant chief nurse, McCool supervised 229 medical personnel and established a skills training program and public affairs section. One of

# The State of Israel: From Beatrice Eisenberg to Batya Yaakobi

The Center for Lifelong Learning (CLL), with co-sponsor Jewish War Veterans Charles B. Krieger Post 567, present a picture of how Israel has developed over a period of 67 years through the eyes Batya Yaakobi.

The program is on Tuesday, June 20, at 2 p.m. in Clubhouse I. Admission is free but ticket registration is required and available at the E&R office in Clubhouse I on Tuesday, June 6, at 8:30 a.m. Refreshments are served.

Yaakobi's story is one that is encompassed by the very change of her name from Beatrice Eisenberg to Batya Yaakobi.

In 1950 at the age of 17, after graduating from high school and considering whether to attend Columbia Teaching College or immigrate to Israel, Eisenberg chose a life in Israel. She has lived there ever since.

Beatrice Eisenberg, now "Batya," lived on a Kibbutz in the south of Israel, not far from the Gaza Strip border. She worked wherever she was needed, as was typical of the kibbutz and its sponsoring organization, Hatshomer

Hatzair. Work included digging for potatoes and working in the laundry room, dining room or kitchen.

While on the kibbutz, she married her American boyfriend, who had made aliyah – immigration to Israel – before her. While living on the kibbutz, they had two children – Yoav and Shlomith.

After nine years together they moved to Tel Aviv. Eisenberg's

husband became an engineer for Motorola, and she taught English as a second language to elementary and middle school students for the next 35 years. During the early years there, she had a third child, a son named Erez.

She now lives in a building for seniors that is quite different from Leisure World. How different it is will be part of her story.

During her 67 years in Israel,

she has watched with pride as the State of Israel has become a secure, large country. She looks forward to discussing Israel from the perspectives of the many changes she has witnessed in her homeland – its difficult beginning, immigration, schools, living conditions, economy, security and much more.

## Even Fountains Get the Blues

**S**prays of water shooting upward are a common sight throughout the community – on the golf course, in front of large high-rises, and just beyond the community's main entrance.

Yet at intervals throughout the summer, only the fountains in Veterans Park in front of Clubhouse I gush water with a distinct blue hue. What gives?

Blue coloring is added once or twice a month to aid in the prevention of algae growth, according to Ronny Cabrera, special projects manager. Clear water can allow too much

sun to penetrate the water and stimulate the organisms that can reproduce to create a mossy, slimy mess in the pool around the fountains.

Too much algae growth would require lots of maintenance hours to empty and clean the fountain area, he said. Some chlorine is also infrequently added to the Veterans Park fountain to ensure cleanliness.

Other fountains in Leisure World, such as those by the Overlook high-rise, use newer, faster filtration systems and require less maintenance – and less algae control – than the Veterans Park fountains.

## Flashback

Long before landscaping contractor McFall & Berry began cultivating Leisure World's current 610 acres, the community was presented with an award for its scenic beauty from none other than the nation's first lady.

In November 1966, just a few months after Leisure World of Maryland's grand opening, Lady Bird Johnson entrusted a national award for "excellence in landscape architecture" to Kenneth BeLieu, Leisure World Foundation trustee.

The coveted honor was one of only 13 "National plant America awards for beautification" given for "unique, attractively decorated building sites and projects."

Attired in a burgundy, three-piece dress suit, Johnson presented the embossed award before a crowd of some 400 nurserymen, officials and business leaders.

The American Association of Nurserymen sponsored the 14th annual award presentation.

After the presentation, Johnson told the audience, "I want to add my personal feeling of delight for the wonderful job the recipients have done. They truly deserve the honor they have received."

# Bullying: Reaching from the Schoolyard to Behind the Screen

A recent seminar at Leisure World on “Cyberbullying and Community Associations” delivered illuminating information about a topic that could affect us in ways we might not have realized.

When residents communicate about issues electronically – through email or on the internet, for example – sometimes discussions can become heated, and reasonable etiquette suspended. The seminar topic, requested by Master Meter Mutual presidents and presented by representatives of the law firm Rees Broome, PC, outlined some of the legal parameters that can mean the difference between unpleasant versus illegal electronic communication.

Attended by Master Meter Mutual presidents and some

of their board members, the April seminar addressed how bullying’s definition has expanded to include electronic communication. A 2008 book, “Bullying Beyond the Schoolyard: Preventing and Responding to Cyberbullying,” defined cyberbullying as the “willful and repeated harm inflicted through the use of computers, cell phones, and other electronic devices.”

The Cyberbullying Research Center elaborates on this definition’s four elements:

- Willful – The behavior has to be deliberate, not accidental.
- Repeated – Bullying elects a pattern of behavior, not just one isolated incident.
- Harm – The target must perceive that harm was inflicted.
- Computers, cell phones, and other electronic devices – This differentiates cyber-

bullying from traditional bullying.

Most of the seminar attendees were unaware that Maryland has passed laws protecting persons from electronic bullying. Some of these laws address:

- harassment (Md. Ann. Code §3-903) – This is behavior directed at a specific person that has no legal purpose, is intended to harass or alarm that person, and that continues after a reasonable request to stop.
- stalking (Md. Ann. Code §3-802) – This occurs when a person engages in conduct that he or she knows (or should know) will place the victim in reasonable fear of assault, injury, death, or other similar specified types of harm; or of any of these actions occurring to a third person (such as a family member of the victim’s).
- misuse of electronic mail

(Md. Ann. Code §3-805) – This includes any electronic conduct directed at a specific person that has no legal purpose, is intended to harass or alarm that person, and that continues after a reasonable request to stop. This is basically the same as harassment, except that the conduct in question must occur electronically.

The presentation also provided further information on how cyberbullying can lead to other legal claims, including defamation, Fair Housing Act violations, breach of confidentiality, and invasion of privacy.

her primary assigned duties was to triage, or sort, patients.

"In a war zone, it's a more critical kind of sorting because you can't waste all your supplies on one or two patients," she said. "The faster you can get them [patients] on the plane and out to a better facility, the better."

McCool spent just three months in Spain, from January 1991 until just after the end of the war, all the while feeling isolated and not knowing the exact address of the base where she was stationed. Eventually, she and the other personnel acquired a television and watched the war on CNN, baffled.

"We thought we were going to get a hundred body bags a day," McCool said. "We were trained for chemical warfare. We had no idea we had gotten so sophisticated that we could fly in unmanned drones."

Although the 401st prepared for the worst, they had no casualties. All training missions practiced by her unit leading up to the war reflected what might go wrong – everything from 'ditching,' or landing the aircraft in water and improvising a medical air evacuation, to working with patients in psychological distress.

After the war, McCool returned to her job as nursing unit and education coordinator at George Washington University Medical Center in Washington, D.C. She took a position with the Federal Drug Administration in 1993 as a senior scientist in its gastroenterology and renal devices branch.

## In a Man's World

At 5'3" with a slim build and blonde hair, cloaked in a tan shawl and wearing too many pieces of jewelry to count, McCool strikes the onlooker as more Stevie Nicks than Gen. George S. Patton.

People would often recog-

nize her military rank on paperwork or identification cards and assume it referred to her husband. "People don't expect that a colonel is a little woman," she said. "And I am a little woman."

Her compatriots even nicknamed her the 'Itsy-Bitsy Major,' then 'The Little Colonel.'

McCool said her presence was often met with surprise, but later respect, once the other crewmen "realized they were dealing with a woman that knows the military, knows all the jargon and knows how to use a gun."

## A Life of Service

McCool received her diploma in nursing from St. Johns Episcopal Hospital in Brooklyn in 1968. After continuing her education with a Bachelor of Science from Brooklyn College in 1974 and studying at the Roosevelt Hospital School of Anesthesiology, she worked as an ICU nurse and instructor in Manhattan.

She joined the Air Force as a captain in 1977 to "see the world," but was instead stationed at Andrews Air Force Base in the ICU – not her dream scenario.

"I was a little too hyper to sit behind a patient giving gas [anesthesia]. If I had lost a baby on my table, I could never have handled it," she said.

After she completed three years of active duty service, she joined the Air Force Reserve, becoming a C-130 flight nurse instructor and assistant chief nurse for the 459th Air Refueling Wing. She remained with the 459th Command as a flight nurse and educational coordinator until her retirement from the military in 1999 after 21 years of service.

"I took my mission, on active duty and in the 18 years that followed, very seriously. We were going to protect our men and women, and stand for the United States wherever we went."

Another constant in McCool's life, besides the military, has been her love of art.

"I've been painting all of my life, but I decided to go into nursing because I didn't think I was going to be Van Gogh," she said.

McCool frequently exhibits her artwork in Clubhouse I; a

still-life watercolor painting and pencil drawing are currently on display in the hallway. She even sold a piece – a painting of wedding shoes – to a fellow Leisure World resident last month.

# Save Energy and Offset Electricity Costs

**A**re you energy conscious? Join the campaign to save energy and moderate electricity usage and, in the process, help offset utility costs.

Working together, Leisure World residents served by the master meter can save on electricity costs and make a profound difference in the operation of the grid. Very little is required to yield measureable results.

## A Consumer-Friendly Program

Each June through September, residents who are served by the electric master meter have an opportunity to take action and save on energy costs.

The Leisure World electric

master meter accounts participate in a Demand Response Program, a consumer-focused effort to reduce energy during peak periods.

In times of peak electric demand, Pepco notifies customers prompting them to take voluntary action to curtail electricity usage.

Once Pepco reaches out to the community, residents will be alerted via Leisure World's automated notification system (One Call Now) and the announcement will appear on the Leisure World television channel. A notice will also be posted on Leisure World's website, residents.lwmc.com.

In return for significantly reducing electricity when requested, Leisure World can earn substantial rebates that help offset electricity expenses for all properties on the master meter.

The following mutuals are on the master meter: Montgomery Mutual and Mutuals 5, 6A, 6B, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 18, 19A and 19B (Buildings 88, 89 and 90). Some trust facilities are also on the master meter and participate in the program.

In 2016, Leisure World's reduced energy performance earned a \$42,000 toward master meter electric expenses. This year, the community is eligible to earn up to \$37,000. (The maximum amount that can be earned is set by PJM, the grid operator, and varies annually.)

If Pepco calls an emergency curtailment event this summer, the community's electricity consumption during the emergency will determine if a rebate is earned and the amount of the rebate. The more electricity conserved during the emergency curtailment event, the greater

the amount of the rebate earned.

If the energy supplier does not announce an emergency curtailment event, Leisure World's performance during an audit period determines if the community can cut back its electric usage sufficiently enough to qualify for a rebate.

## Easy Ways to Save Energy

What can you do to reduce energy usage? During emergency events, residents of master metered mutuals can take a variety of actions to reduce or shift electricity usage.

Recommendations include unplugging unnecessary electrical devices, closing window coverings, raising the thermostat on the air conditioner, using fans rather than an air conditioner, and avoiding use of the dishwasher, washing machine, and/or dryer.

Emergency curtailment events begin Thursday, June 1 and run through Saturday, Sept. 30 between noon and 8 p.m., and are likely to occur on hot "code red" days during weekday afternoons.

Advance notification by the utility for an emergency event is just 30 minutes prior to the scheduled curtailment time.

It is important to stay alert for notifications during the high probability days and to take timely action to reduce electric usage during the designated period.

Throughout the notification season, a weekly forecast of any high probability days will be posted on (residents.lwmc.com). However, no actions to reduce electricity usage will be needed until an actual event is called.

Participation in the Demand Response Program is a clean, reliable alternative to the construction and use of power plants to handle peak electricity demand on hot days.

The reduction of energy usage by Pepco customers helps to ensure the overall reliability of the grid system in the region and to minimize the occurrence of brownouts.

Most importantly, it helps to reduce energy costs, thereby benefitting Leisure World residents. Join the campaign and make a difference.

# Community Attends Annual Health and Wellness Expo

approximately \$171,000 in contributions, whereas May saw 29 property transfers that generated about \$110,000.

"That's about an average month after a very robust April," Flannery said.

Leisure World consultant Dave Merritt has begun implementing the overall change out of hardware throughout the LWCC, particularly copying machines, at an approximate projected savings of \$20,000 a year to the corporation, and an \$1,800-3,000 savings for each mutual.

Merritt is also assisting LWCC's operations to move

"away from the pushing of paper," and towards an electronic filing system, Flannery added.

LWCC has signed an approximately \$8,400 contract with a vendor to provide employee-wide online course training, with course topics ranging from workplace safety to career development.

### Bulk Internet

The board passed a motion that tasks the Special Information Technology Committee and management to develop parameters for a new Broadband Communications Services contract.

The new resolution replaces a January 2017 motion that authorized the

general manager to investigate bulk internet service for the community.

Currently, 70-75 percent of Leisure World homes have internet service, Flannery said. The new resolution examines amending the current Comcast cable TV bulk contract to add bulk rate internet before the mid-2020 expiration date.

Under this resolution, the Committee and management will assess both resident and management broadband requirements, and research market providers' services and products for "Smart Communities," areas which use technology in a secure fashion to reduce costs and resource consumption.

Final recommendations to

the board will list selected provider options, all costs, and a comparison to the current bulk cable TV services contract.

### Outdoor Pool Opening Delayed Until June

**D**ue to required repairs and renovations, the opening of the Clubhouse I outdoor pool, which had been scheduled for Saturday, May 27, has been delayed. The outdoor pool reopens on Saturday, June 3.



### A Note on Home Improvement Contractors

**M**aryland law requires home improvement contractors to be licensed by the Maryland Home Improvement Commission. Consumers who do business with licensed contractors are protected against losses by the Home Improvement Guaranty Fund; consumers who do business with unlicensed contractors are not.

### Drivers Must Yield the Right-of-Way to Emergency Vehicles

**P**er State Law: "Authorized emergency vehicles, such as police cars, ambulances and fire engines, have the right-of-way when they are giving a signal, either audible (siren) or visual (flashing light)."

On hearing or seeing such vehicle approach, you must immediately drive to the curb and stop. Once the emergency vehicle has passed, you may proceed back onto the roadway. Failure to follow this law may possibly delay lifesaving services to the call.

## Civility Matters

On Jan. 31, I attended the monthly board meeting of the Leisure World Community Corporation (LWCC) and came away with many questions as to what I had witnessed. What began as a seemingly routine discussion of agenda items gradually morphed into a verbal melee replete with shouts, accusations and innuendo. By meeting's end, any semblance of order and civil discourse was suspended. It was ugly.

Was this debacle an aberration? Admittedly, the tone was less contentious at the February meeting; the tacit rebukes often leveled at those who have different views from those of management were kept to a minimum.

Here is what I took away from those meetings: 34 of our neighbors volunteer their

time and energy to serve as directors on this Board to represent 8,000 of us living in the Leisure World community. Where documented, their commitment to act in the best interest of the residents of our community is laudable and worthy of our recognition and support. However, in times of lingering doubts and unresolved conflicts, it is the duty and responsibility of our residents to weigh in with our concerns and suggestions. And we should not be disparaged or deterred in our attempt to do so. Debate, when conducted properly, is healthy. Disrespect is not.

In any organization, it is not unreasonable to expect controversial issues to generate robust and spirited discussions. Thus, the open forum that takes place at board meetings is extremely important. Non-board members often raise important questions

that have not been asked and responses to those questions can provide invaluable information to everyone present. However, questions often asked by non-board members during open forum are not answered. Why is this allowed? Is the board's lack of transparency and objectivity merely a perception? Is it any wonder that residents are frustrated and dissatisfied with our governance?

Proposals that affect us as stakeholders are worthy of our concern – a concern that is certain to generate questions that need to be listened to with an open mind and responded to with thoughtful consideration. One such proposal involves building a new Administration Building. A petition comprising 550 signatures in opposition to that proposal was submitted to the board; for many of us, it is impossible to fathom why this petition was shelved. Would a petition with the signatures of 550 residents in favor of the project have been similarly treated? Many of us feel that every resident in this community should be given the opportunity to weigh in on this important issue. Why is there such opposition by most of the board members to consent to this suggestion?

There is certainly no

scarcity of written material about successful governance. Montgomery County's Commission on Common Ownership Community's "Common Ownership Community Manual & Resource Guide" includes such relevant topics as "governing reasonably," "practicing justice for all," "preventing and resolving conflicts," and "encouraging consensus." It also provides several guiding principles such as: "identify controversial issues and engage in interactive communication with the community," "seek community input prior to controversial decisions by the board," and "understand minority views."

The application of these basic principles would signal an honest attempt to build a healthy working relationship between the board and the other residents of our community. The failure to do so will continue to raise legitimate questions and concerns about the efficacy of governance in the Leisure World community. And the discord will continue.

I believe we can do better.

### FISH Depends on Generous Donations

**F**ISH is a volunteer organization in Leisure World. We receive donations of assistive equipment, and then we lend the equipment to residents and employees.

We do not charge anything; you may borrow the equipment for free. Occasional donations of cash help us purchase office equipment and hold an annual volunteer meeting.

#### Equipment

Our equipment is used. We do our best to discard any unsafe equipment, however, our members are volunteers and not medical experts.

We encourage users to check in with a therapist about the use of the equipment. If you have any doubt about the condition of a piece of equipment, return it to FISH and check if there is another one available.

#### Borrow First

If you are thinking about purchasing a piece of equip-

ment, it's a great idea to borrow it from FISH first.

If it doesn't work out, or you discover that there is a feature you want, you are free to return the item.

If you purchase equipment, you may not be able to return it to the medical supply company. And if you have used Medicare, you may not be eligible to purchase another through Medicare.

#### Organization Information

FISH is located in Clubhouse II and is open Monday to Friday from 10 a.m.-4 p.m. After hours, the E&R staff can accept returns and help a person borrow something.

choices. Several nationally known spokespeople with diverse points of view appear in the film.

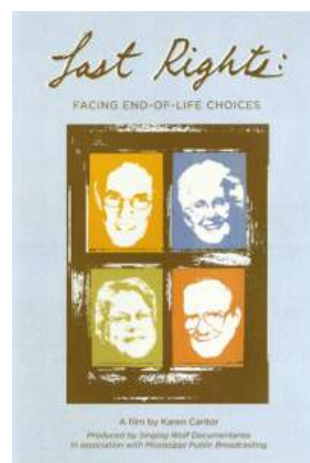
An opportunity for discus-

# June 30: 'An Approach to Enhance Health and Well-Being'

The Mental Health Subcommittee of the Health Advisory Committee presents a lecture entitled "An Approach to Enhance Health and Well-Being" on Friday, June 30, at 2 p.m. in Clubhouse I.

The lecture is presented by Dr. Sarah Kagan, the Lucy Walker Honorary Term Professor of Gerontological Nursing at the University of Pennsylvania and a gerontological clinical nurse specialist in the Living Well Program at the Joan Karnell Cancer Center.

Kagan, a MacArthur Fellow, presented a lecture last year to an enthusiastic and sold out audience, and her return is long anticipated.

She aims to engage the audience and provoke critical contemplation as she presents a variety of topics to different audiences around the world. In visiting Leisure World, she anticipates a lively discussion about

"An Approach to Enhance Health and Well-Being."

There's a good deal of talk about aging gracefully. The phrases 'aging gracefully' and 'growing old gracefully' offer a good deal of cachet but less clarity about grace and what it means as we grow old.

Grace – in physical, mental, emotional, spiritual and social dimensions – influences aging and later life, but often the question is just how it does so. In this workshop, Kagan explores the different dimensions of grace as an approach to aging well.

Potential threats to grace as we age are defined. Important resources to promote grace and enhance health and well being in later life are discussed, using examples drawn from current science.

of the nine Book Club Network clubs as well as a few people on our waiting list. Members brought a dish to share as well as up to five books for the exchange table. In return, they could take as many books

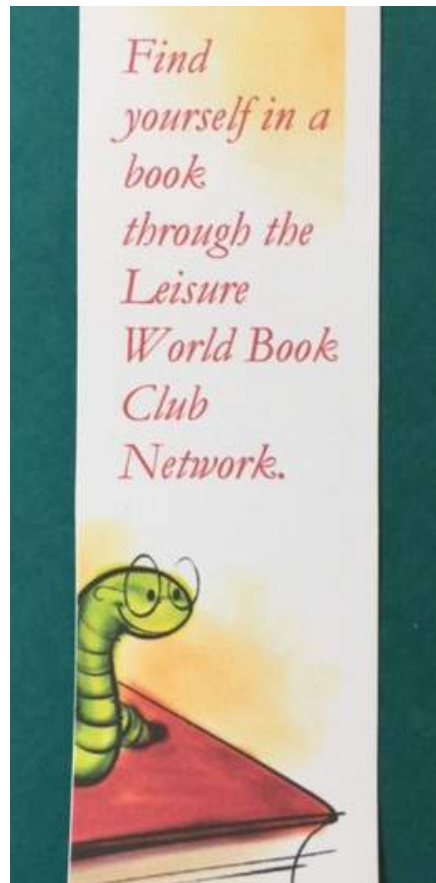

# June 14: 'Exploring the Geology of Maryland'

The next meeting of the Gem, Lapidary, and Mineral Society (GLMS) of Leisure World is Wednesday, June 14, at 7 p.m. in Clubhouse II. Club member

Tom Rounds presents a program entitled "What's Under Your Feet? Exploring the Geology of Maryland."

Geologic processes such as volcanism, mountain building, erosion and deposition have shaped our planet into amazingly varied landscapes with diverse and remarkable topography. Geologists study solid matter such as rocks and minerals to find explanations for Earth's structure. As it turns out, Maryland is a perfect place to discover the vast history of geologic time.

Maryland in cross-section runs from the Atlantic Ocean in the East to the Allegheny Plateau in the West. Along this cross-section lie four geologic provinces: Coastal Plain, Piedmont, Blue Ridge, and Appalachians. Each province has unique rock types (and in some cases fossil types)

that define its geology and tell the story of its history.

The Coastal Plain, the youngest province, has sedimentary deposits derived from erosion of the ancestral Appalachian Mountains in the West and deposition in river floodplains and the ocean waters of the Continental Shelf to the East.

Calvert Cliffs State Park, a popular fossil locale on the Chesapeake Bay, lies in the Coastal Plain and exposes sediment containing seashells and sharks' teeth from the Miocene epoch nearly 20 million years ago.

The Piedmont lies beneath and to the west of the Coastal Plain. Erosion, caused by the great force of the Potomac River over the last million years, has exposed a cross-section of Piedmont rocks, the predominant feature of Great Falls Park.

The Blue Ridge is situated between the Piedmont and the Appalachians. In Middletown Valley, it exposes some of the oldest rocks in Maryland, including the 1.1 billion-year old "basement" rock, so called because it underlies all of eastern North America. From High Knob Overlook in Gambrill State Park, the hiker has an expansive view of the Blue Ridge Mountains as well

as Middletown and Frederick valleys.

The Appalachians, as the westernmost province, lies to the west of South Mountain and contains rocks ranging in age from 200 million to 600 million years old. They were deposited in the shallows, shores and coastal river systems of the ancient Paleozoic seas that once covered much of eastern North America.

A road-cut through Sideling Hill west of Hancock is considered the best rock exposure in the northeastern United States. It offers visitors a spectacular view of almost 810 feet of strata in a tightly folded syncline.

If you've ever wondered what's beneath the ground you walk on, join us June 14 to learn more about discoveries you can make yourself, even if you're not a trained geologist.

Rounds's presentation explores geology with an emphasis on the roadside geology of Maryland.

If you wish, bring an item for show-and-tell. Rounds has offered to help with identification, to the best of his ability.

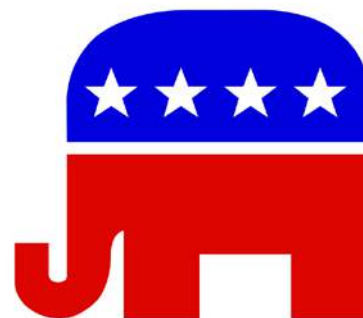

# June 19: Last Chapter Meeting Before Summer Break

The Chapter's membership meeting on Monday, June 19, is the last meeting before summer break. Informal discussions and snacks begin at 1:30 p.m. in Clubhouse I, and the formal meeting begins at 2 p.m.

The Chapter cannot confirm the guest speaker at this time. Over the summer, the executive committee will continue to meet and will brief and train new committee members and volunteers to improve the organization, administration and value of the Chapter.

## Federal Retirement

The details of President Trump's FY 2018 budget include many proposals that would reduce federal retirement. The proposals include:

- calculating future retirement benefits based on the average of the high-five years of salary instead of the current high-three
- reducing cost-of-living adjustments (COLAs) by 0.5 percent from the current formula each year for retirees under the Civil Service Retirement System (CSRS)
- eliminating COLAs for current and future retirees under the Federal Employees Retirement System (FERS)
- increasing FERS retirement contributions up to six percent to equal the government's contribution, with no increase in benefits
- eliminating the FERS Annuity Supplement beginning in 2018

## Competitive Compensation

The House Committee on Oversight and Government Reform held a hearing titled "Federal Employee Compensation: An Update." The hearing addressed a recent Congressional Budget Office report, which compared federal compensation to that of the

private sector. In general, the report concluded that:

- Federal civilian workers whose highest level of education was a bachelor's degree earned five percent more, on average, in the federal government than those in the private sector.
- Federal civilian workers with no more than a high school education earned 34 percent more, on average, than similar workers in the private sector.
- Federal workers with a professional degree or doctorate earned 24 percent less, on average, than their private-sector counterparts.

NARFE submitted written testimony to the committee expressing support for competitive compensation and iden-

tified some of the flaws and limitations of the report. While federal benefits are on average higher than the private sector, the Federal Salary Council has reported that federal workers are paid, on average, approximately 34 percent less than their private-sector counterparts, based on data by the Bureau of Labor Statistics.

In meetings with Congressional and Senate delegation, we are consistently asked to give personal narratives of some of the important work that we performed or accomplished during our times as federal employees. Please consider some of your experiences and submit them to your representative and/or discuss your ideas with our Chapter president or vice president.

We are delighted with the support of Pam O'Dell, who has

been nominated by the executive committee to be our new secretary. Jewel Lee, who has been procuring and setting up refreshments for our meeting, has agreed to be the next Chapter treasurer. We also appreciate the support John Lass is providing to the executive committee.

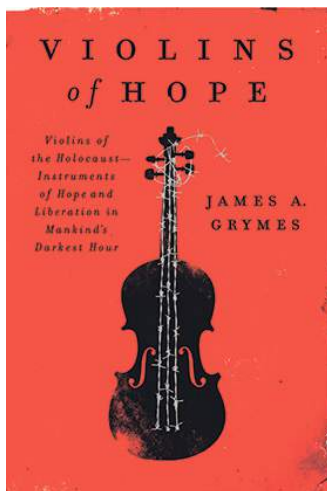

# Conquer the Mac Dock: Part 2

by Brent Malcolm

Any application's icon can be dragged to the Dock to the left of the separator, ready to be clicked to launch the app.

The Dock space to the right of the separator is used to store: (1) the Trash; (2) the icon of any running app that does not have a permanent Dock icon; (3) any folder or document that is dragged into this section.

The latter use is very handy when you want to have a document available to be opened quickly. To remove anything from the Dock, just drag it away until the "Remove" label appears, then release the mouse.

The Dock has some other overlooked capabilities. Right click on an icon in the Dock and a contextual menu appears with various choices depending on whether the app is open or closed, plus some application-specific items.

The label "Options" with a display triangle will appear with all icons. Clicking the display triangle reveals these choices: (1) "Keep in Dock" if the app is running or "Remove from Dock" if the app is not running; (2) "Open at Login" (this app will then automatically open when you login); (3) "Show in Finder" (opens Finder window that contains the app or document). There is also an enigmatic set of commands about Desktops under the heading, "Assign To."

Users can drag any folder into the Dock. One folder that should always reside there is the Downloads folder, which receives downloads from your browser.

Right clicking can modify the way any folder in the Dock and its contents is displayed. The folder options are as a Folder or a Stack.

Users can choose to show the contents of the folder in a number of ways: as a "fan" of icons (best when the folder only contains a few icons), as a grid of icons, as a list of items; or users can have macOS select the best view based on the number of icons in the folder (by selecting Automatic). The folder can also be sorted by Name, Date Added, Date Modified, Date Created, or Kind (of file). There's a menu item to open the folder in the Finder.

The last Dock icon is the Trash, whose right-clicking options are Open or Empty Trash. Users can stop the warning that appears when trying to empty the Trash in the Finder Preferences, Advanced tab.

### Today's Tip - Forward a Text Message

Have you ever wanted to forward a text just the way you can with email? Just hold your finger down on the actual text message that you want to pass along. When the More button appears, tap it, then tap the curly Forward arrow.

His favorite bridge story took place several years ago at a regional bridge tournament. Before the start of a round against another pair, he had to leave the bridge table for a few minutes and asked his opponents to watch

his coffee.

When he returned to the table, he thanked his opponents for being courteous and patient and then proceeded to beat them and win the round. Later in the session, he was told the pair he just beat, unbeknownst to him, was none other than Jeff Meckstroth and Eric Rodwell, the top players in the U.S.

That's what bridge is all about: a lifelong game that promotes friendly competition, respect, courtesy, trust and, above all, having fun. So come on and join the fun. See you all at the bridge table.

**G**en. David Petraeus is back in the news again. In February, he testified before the House Armed Services Committee on threats to world order.

The retired four-star general resigned as Director of the CIA about five years ago because of a scandalous affair with Paula Broadwell, his biographer. He should have played chess instead.

Petraeus served over 37 years in the U.S. military, including command of coalition forces in Iraq and Afghanistan. He graduated with distinction from the U.S. Military Academy at West Point, earned M.P.A. and Ph.D. degrees from Princeton University, and is currently affiliated with three universities (CUNY, USC, Harvard). He is the recipient of numerous U.S., NATO and U.N. medals and awards, and decorations from 13 foreign countries.

Petraeus met Hollister “Holly” Knowlton on a blind date. She is the daughter of Gen. William A. Knowlton, who was Superintendent of the Academy at the time.

The couple married on May 12, 1974. Mrs. Petraeus worked in jobs providing consumer education and advocacy for military personnel and their families. She retired in January 2017 from the Consumer Finance Protection Bureau (starting annual salary \$187,605). She and her two children never spoke publicly about her husband's affair.

In May 2013, Petraeus became a partner in Kohlberg Kravis Roberts & Co. L.P. (KKR), a New York investment firm, and chairman of the firm's newly created KKR Global Institute.

In July 2013, Petraeus was named a visiting professor at the City University of New York. He was to be paid \$200,000 to deliver a three-hour weekly seminar. Full-time professors and adjuncts earn far less at CUNY for teaching a full load of classes.

After city and state officials criticized the high pay, Petraeus agreed to take the position for just \$1.

Paula Broadwell, 20 years younger than Petraeus, served on active and reserve army duty for over 20 years. In her hometown, Bismarck, North Dakota, she was homecoming queen, valedictorian, and an All-State basketball player. She earned a bachelor's degree from West Point and a Master of Arts degree from the University of Denver.

A New York Times article quoted sources describing her as an “ambitious overachiever;” an “Olympic-distance triathlete” who could run a six-minute mile; “curvaceous,” with “expressive green eyes;” and “seemingly immune to the notion of modesty.”

thored a biography of Petraeus, published in January 2012. She remains married to Dr. Scott Broadwell, whom she met when they both were captains in the U.S. Army. They have two sons. She is best known for her extramarital affair with Petraeus.

As fallout from the affair, Petraeus resigned from the CIA and later pleaded guilty to a misdemeanor charge of mishandling classified material. He was sentenced to two years' probation and a \$100,000 fine.

It is not true that he had to wear a scarlet letter “A” alongside his service ribbons. Broadwell was never charged. However, she lost her security clearance and her promotion to lieutenant colonel.

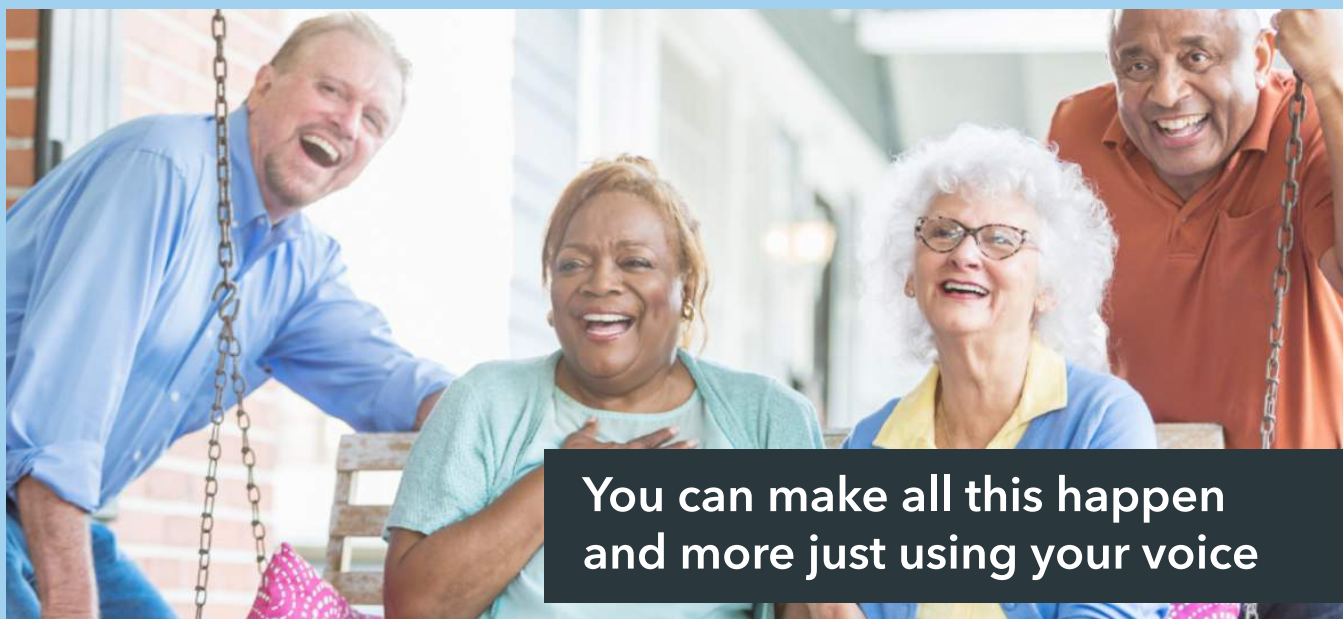

# Tournament Winners Receive Master Points

On May 9, the Duplicate Bridge Club participated in the American Contract Bridge League District 6 Sectional Tournament at Clubs (STaC). Although the Leisure World bridge players saw no difference from other Tuesday games, the top finishers received significantly more master points. Sectional tournaments are held a number of times a year, usually at other area locations in Maryland or Virginia; but bridge clubs are permitted to participate in STaCs, which occur four times a year. All points won in sectional tournaments are classified by the ACBL as Silver Points, which are a necessary requirement in achieving the status of Life Master. In STaC games, the partic-

ipants are grouped into three strata, depending on the average number of master points held by the pair. Stratum A includes all players; Stratum B includes those pairs whose average master points are less than 1,500, while Stratum C includes those pairs whose average does not exceed 500 master points. Players are compared both against others in the Leisure World game, and against all others playing the same hands at other locations. Printouts of the hands played were available at the end of the game. Maida Crocicchia, sitting North-South, and playing with Marilyn Udell, Stratum B players, attained more than 71 percent of the available match points. Theirs was the highest score among all players in the May 9 STaC game, including Stratum A players who have significantly

higher master point totals. For their success, they received 4.13 master points, about four times the amount in other bridge games. Other Leisure World players who scored among the highest participants were:

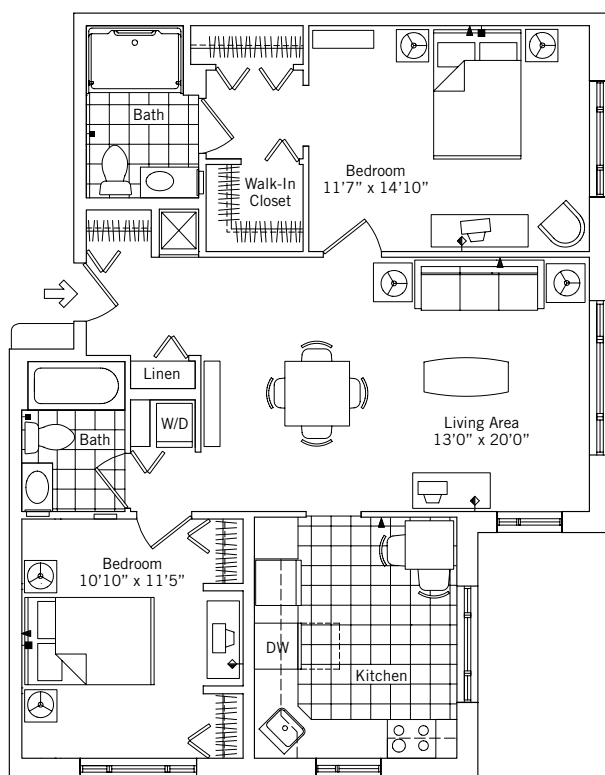
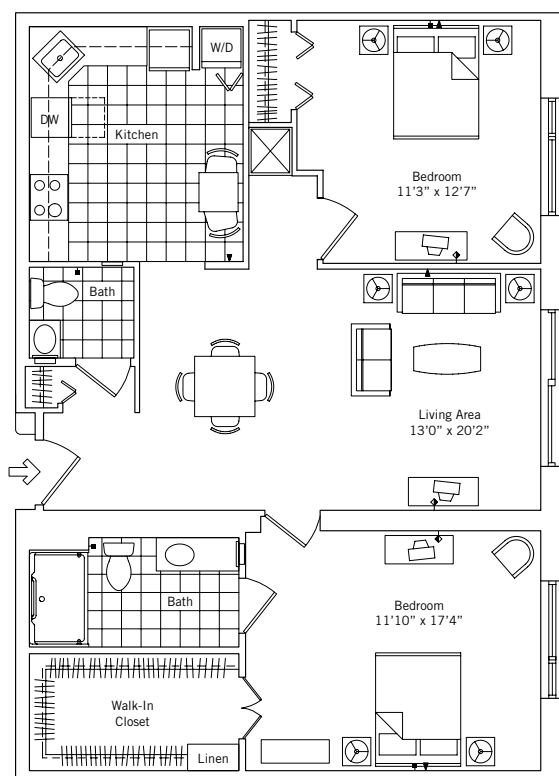

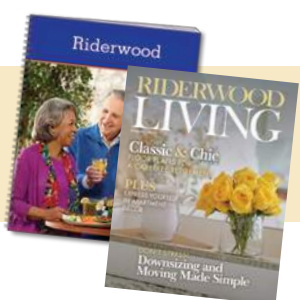
