LWCC to Maintain Barrier Fence and Fund Woodshop Lift

Mutual 13's request for the Leisure World Community Corporation (LWCC) to maintain a planned barrier fence along mutual property at Georgia Avenue was approved at the regular meeting of the LWCC board of directors on May 21.

The Maryland State Highway Administration has agreed to purchase and install the 12-foot barrier fence, which is designed to reduce the visual and noise disturbance created by vehicle traffic along Georgia Avenue.

The barrier will be made of heavy-duty vinyl and will replace the chain link fence currently at that location. Installation is expected to begin in late summer.

Capital Equipment Purchase

The board approved the Budget and Finance Advisory Committee's recommendation to allow the woodshop in Clubhouse I to purchase and install a lift at a cost of approximately \$15,000.

The board fast-tracked the purchase of the lift to coincide with the woodshop's floor replacement.

The money to purchase the lift will come from the 2020 Capital Equipment Fund, and the Wood Shop Users Group is contributing an additional \$5,000 toward the purchase.

The lift will allow members of the Wood Shop Users Group to place large pieces of lumber in a

storage space away from operational areas of the wood shop.

Golf

The board decided in a 15-13 roll call vote to postpone taking action on the Golf and Greens Advisory Committee's recommendation that a consultant complete an infrastructure study for golf course enhancement.

The approved motion requests that the Committee provide more information about the proposed study within the next month.

The original golf course enhancement plan was developed approximately seven years ago, but technological advancements in golf course maintenance, particularly drainage, have created an opportunity to review this original plan with the objective of improving the golf course and saving money, according to the rationale for the resolution.


Revisions to the Committee's charter were approved. The revised charter makes adjustments to the Committee's areas of responsibility and removes "general overall background in the design of golf courses" from the Committee's preferred member qualifications.

2020 Operating Budget

A preliminary report on the development of the 2020 operating budget was presented to the board, which included discretionary and non-discretionary expenses. The process of final-

Former Footballer and Local Newscaster Headline July 4 Parade

Plans for this year's July 4 parade and festivities are shaping up to include some of the old, some of the new – and two famous faces likely recognizable to residents familiar with local sports and news casting.

Former Washington Redskins defensive end Dexter Manley will serve as the parade's honorary grand marshal, waving to the crowds who gather along Leisure World Boulevard. And after the parade, NBC4 reporter, TV anchor and legal analyst Chris Gordon will give the keynote address to parade-goers who gather at Veterans Park outside Clubhouse I.

Football Legend

Manley, nicknamed the "Secretary of Defense" for his defensive end skills, was first

drafted by the National Football League in 1981 and played for the Redskins for nine seasons.

He won two Super Bowl titles with the Redskins and is the team's all-time sack leader. He has been nominated for the Pro-Football Hall of Fame every year since 1986.

These days Manley's success extends off the field as a philanthropist with a mission to 'sack' illiteracy and substance abuse through programs for youths and families.

Residents are invited to show him some love by wearing their Redskins jersey or simply cheering from the sidelines as he winds his way down the parade route in a convertible car.

izing the 2020 operating budget will begin in mid-June.

HR Report

HR director Ron Pancotti discussed the retention and recruitment of Leisure World employees, and recommended the board explore allocating additional dollars to attract new employees, retain current employees and “compete with some of the outside forces that are looking at the same workforce.”

Leisure World’s aging workforce, combined with a deficit in trade workers, will represent a significant challenge to Leisure World in the near- and long-term future, he said.

Administration Building

The Maryland-National Capital Park and Planning Commission is preparing a recommended safety resolution for the Administration Building and Clubhouse I Site Improvements Project that will be presented for approval at

the Commission’s upcoming meeting. Once approved, an architect will be hired for the project.

The project’s original architect, Streetsense, is no longer involved. The project’s delays caused some of the company’s staff to find work at other firms, and the company has also altered its business model to focus on design branding, brokerage and market research services.

The board voted to enter into a closed session at the end of the regular meeting to discuss personnel matters.

Board to Consider Bulk Cable TV and Internet Service Agreement

After much negotiation, a tentative agreement with Comcast for bulk internet and cable TV service was distributed by management to the Leisure World Community Corporation board of directors, Comcast representatives and Leisure World's technical consultant, Columbia Telecommunications, on May 28.

Board members have been asked to review the agreement and provide their comments before the board takes any action on the agreement at its Tuesday, June 25 meeting.

If the board of directors accepts the proposed eight-year agreement, both cable TV and internet service would be provided to all homes in Leisure World at below market price beginning Wednesday, Jan. 1, 2020. The current bulk contract includes cable TV only.

Pricing

Under the proposed agreement, Leisure World residents would receive both internet and cable TV service for \$55** per month (see below). For comparison, Comcast charges individual Montgomery County residents \$69 per month for internet service only.

Up to four digital converter boxes, two of which are high-definition, and a modem would be included in this rate. The Comcast internet service

provided for in the contract is Extreme Pro! high-speed internet at 400 Mbps down and 10 Mbps up.

Residents would also have a cable TV channel lineup that is similar to what is included in the current bulk contract, and would be able to retain any premium channels or other a la carte items that they already subscribe to with Comcast outside of the bulk agreement.



System Upgrades

The proposed agreement also includes significant upgrades to the cable and internet infrastructure of the common areas of the Trust and of the mutuals.

If the board accepts the agreement at its next meeting, Comcast will start making these improvements beginning Monday, July 1, and they would be expected to take five to six months to complete.

More information about installation and features of the bulk cable TV and internet will be forthcoming if the agreement is accepted.

Resident Survey Expected to be Mailed in Coming Weeks

A strategic plan will provide the community with a roadmap for its future, and every resident will soon have an opportunity to contribute to it by way of an anonymous survey delivered right to his or her mailbox.

The Special Strategic Planning Committee (SSPC) has worked with consultants from George Mason University (GMU) to create survey questions that explore how the community sees itself, and what it would like to see in the future.

Residents can expect the survey to be mailed to each unit in the next two to three weeks, pending university

approval of the survey questionnaire, according to Dr. Terry Clower, director of GMU's Center for Regional Analysis.

Survey questions cover current and prospective amenities and services and will gather data about the community's demographics. The SSPC encourages every resident to complete the survey as soon as possible. Residents have the option of completing the

survey by hand and mailing it back or filling it out online.

Housing purple martins has a long history; Native American tribes hung hollow gourds around their villages to attract them, according to the Audubon's online guide to North American birds.

The purple martins in Leisure World will migrate south in late summer.

These initiatives were among several that came out of a series of interviews and work sessions held with numerous clubs and organizations earlier this year. The organization's first annual fund campaign will include an adoption of funding goals needed to cover the costs of projects currently slated for implementation and a formal mechanism to honor donors, except those who wish to remain anonymous.

Past grants from the Foundation funded nearly all the equipment in the Computer Learning

Center, pianos and lapidary equipment, the annual Art Show, the 50th anniversary yearbook and some of the more recent E&R programs, such as performances by the Fabulous Hubcaps and Still Surfin,' a Beach Boys tribute band.

Communications Plan Starts to Take Root

Early in 2018, the Leisure World Community Corporation board of directors tasked the general manager, in coordination with the Communications Advisory Committee (CAC), to prepare a comprehensive plan for improving communications with residents and potential residents. That plan was delivered to, and

accepted by the board in October 2018.

A central tenet of the board's request was that Leisure World can do better than mainly providing news to the community twice a month through the Leisure World News.

In order to address the mandates of the plan adopted by the board, the CAC has taken several steps:

1. The CAC formed a working group to explore opt-in email communications as an additional communications channel to residents to provide them with timely information. The working group has identified several ways an email service can add value to the community.

While it was not a comprehensive survey, a member of the CAC contacted two other Leisure World communities, one local and the other in California, and they both currently offer well-designed, useful email

programs for their residents.

2. The CAC is considering alternate website platforms to address some of the shortcomings that the Communications Department has experienced with the current platform vendor, FrontSteps. A working group has just been formed to explore this issue. The CAC believes at least one additional employee is required in the Communications Department to implement any of the new initiatives outlined in the board-mandated plan.
3. The Committee is in discussion with management and the Budget and Finance Advisory Committee to consider staffing requirements to implement the board-mandated plan.

Not only do electronic communications provide more timely information, they also allow information to be provided in

alternate formats. For example, (residents.lwmc.com) provides ADA-compliant copies of Leisure World News, so that sight-impaired residents can enjoy the paper. And if the CAC and staff implement a capability to deliver timely news and information by email, snowbirds and traveling residents will be able to stay up-to-date with events back home.

The CAC believes that unlike individual amenities, the use of online communications is, and certainly will be, much more ubiquitous. While few, if any, residents take advantage of every service and amenity available in the community, a much larger percentage are likely to use the website, email and similar electronic media. It is the mission of the Communications Department, in consultation with the CAC, to provide residents with high-quality communications services, and that means seizing the advantages that technology provides.

They failed to block the Administration Building before the planning board. They failed to overthrow the Leisure World Community Corporation board of directors. They failed to change the governance of Leisure World. They failed to do all of this in court. But they are not done. They have embarked on a strategy of starve the beast. They are in court to overturn the two percent Leisure World resale fee. This fee goes to the Resales Fund. The Fund provides for the repair, improvement and replacement of the common areas. That includes the clubhouses, guardhouses, landscape, swimming pools, fitness center and other areas. Look around you and think about the beauty of this 50-plus year-old property. This beauty can in part be attributable to the two

percent fee.

It is not surprising that with a population of approximately 8,000 there will be malcontents. Most of the dissatisfaction comes from one high-rise. These folks have made unfounded charges about wasted money and poor maintenance. The truth is just the opposite. Leisure World is beautifully run and maintained.

If the two percent fee were eliminated that would be unfair to all the owners who paid the fee when they purchased their homes. Those fees paid for the clubhouses and other amenities. The newcomers would in effect be free riders, and money would not be available to keep up the property. These legal battles are costing all of us money. Since the plaintiffs have lost in court they could be sued for legal expenses. I hope the board pursues them.

ENERGY WASTE

On May 22, LW Green sponsored an interactive event on energy conservation presented by Montgomery

County Department of Environmental Protection representative Larissa Johnson to an overflow audience. Clearly, there is concern and desire by the public to conserve natural resources, especially if they are cost-effective to the consumer. The presentation’s focus was on LED light bulbs, which outlast all other types; and three bulbs were given free of charge to each attendee.

But light bulbs that consume less energy are not the only way to become more “green.”

As a food researcher and writer, I continue to be appalled by the recipes that continue to be written and published in cookbooks, magazines and newspapers. They hark back to more than 100 years ago, when kitchen ovens were still heated by wood or coal.

Some also indicate the total preparation time for chefs (more for amateur cooks) is typically about 30 minutes before the food is inserted into the oven. My oven takes six minutes to reach 350 degrees and eight minutes to reach 425 degrees, which means that the empty oven would be burning electricity for 24 to 22 minutes wastefully. A sampling from my recipe file of three typical recipes, a chocolate bundt cake, roasted potatoes, oven-browned meatballs, foods that one might make within a week, amounts to 84 minutes of wasted electricity just for those three recipes, while additionally heating one’s home. This also calls for additional air-conditioning to add to the power waste!






is about realizing that even though life as you know it may never be the same again, you can, and must, move forward with your life.





How did the early American settlers make mortar to cement the rocks for their building foundations? One theory suggests they heated limestone in a fire to make lime, while another claims they heated seashells.

Dana Linck, the speaker for the Gem, Lapidary and Mineral Society's (GLMS) meeting on Wednesday, June 12, discovered a simple, scientific method to test the building foundations to determine which theory was correct. The solution was taken right out of the forensic methods used by police departments. Come to the meeting to learn

about his method and how it's applied.

Geology and archeology have developed by leaps and bounds. Improvements in science made advancements in technology possible. Concepts

taken for granted today such as plate tectonics and asteroid extinction of the dinosaurs would have been considered unbelievable in the past.

In contrast, the settling of America is very recent history compared to the evolution of animal life over millions of years.

Linck will demonstrate how the sciences of geology and archeology interface. He will take the Group through some of his professional

experiences — from prehistoric sites in the wilderness of the Alaskan North Slope to a colonial era Long Island homestead.

About the Speaker

Linck has been interested in archeology since age 10. Over a career spanning 58 years, he has done archeological surveys, excavations and evaluations for the National Park Service and the Federal Emergency Management Agency, as well as for schools and private companies.



■ **Ceramics Club**

Club Members Creat Majolica Pottery

Robert Devers, an art instructor in the Visual Arts Department at Maryland College in Takoma Park, recently presented a three-hour workshop on Majolica pottery to Ceramics Club members. Tiles made during this workshop are on display in Clubhouse II through June.

Under Devers' instruction, members recreated the Majolica tile look using graffito paper – sheets embedded with a ceramic underglaze – to trace designs onto bisque tiles which were then painted with a ceramic underglaze. The tiles were then fired, glazed and fired again.

Devers explained that Majolica, also referred to as

Maiolica, was originally used to describe wares made in Mediterranean Europe and primarily exported through the port of Majorca (Spain) and Italy. It was the first modern European pottery to produce rich, glossy colors.

A tin glaze was applied to the red clay terracotta body, providing a white, opaque base over which decoration was applied. The practice of tin glazing spans thousands of years dating as far back as the 13th century. Although there are potteries that still use tin glazing to create Majolica, nowadays Majolica pottery is created on an already white bisque (fired clay) with lead-free glazes.

Majolica pottery had its inception in Mesopotamia, its flow-

ering in Islamic culture, its heyday during the Italian Renaissance and, now, its revival around the world. The superiority of this pottery has made it a very collectible form of art.

June 24: Annual Meeting Features Costa Rica Trip Photo Slideshow





Leisure World.



Chapter members already

knew what Howard Trowern, the guest speaker at the May 20 membership meeting, did for this country.

The front-page feature article in the May 16 issue of the Leisure World News recounted how he lied about his age to enlist in the Army; fought his way across

Europe; suffered three wounds, one from a bullet that penetrated his helmet; served under Gen.

George S. Patton in many battles, including the Battle of the Bulge; and much more.

The excellent article told readers what he did, but the printed word

has limitations. People have to meet Trowern in person to know who he is. He spoke to Chapter members from the heart and from the memory – without script, without notes and without electronic devices.

Mostly this veteran who has done so much acknowledged his gratitude to others: the medics who constantly exposed themselves to danger to save others, the people who supplied the Army and The Rockettes who welcomed him to New York harbor on V-E Day by dancing on a barge towed around his ship.

So much happened to Trowern that a single article couldn't cover it all. We learned that he was a "mustang" – a soldier who attained every enlisted rank then became an officer. He led the unit that liberated the concentration camp at Buchenwald. At his request, Gen. Patton came to the camp to see what could be done to help the survivors. His mother pushed his wheelchair in the victory parade.

Trowern and his buddies selflessly put their lives on the line time and time again. In addition to love of country, they had something else in common: none of them got rich fighting for this country.

Don't Look Up Chess in the White Pages

Most states require that telephone directories be printed and distributed free of charge to customers as a public service.

However, in recent years some states have granted permission for telephone companies to use opt-in or opt-out systems so that only those who request a directory will receive one. As a result, the telephone directory is nearly obsolete.

Manufacture and distribution of phone books is expensive. Over the years, telephone companies have tried to reduce the size and weight of directories by using thinner paper and abbreviations, and even inventing their own typefaces such as Bell Gothic and Bell Centennial.

Yet production still consumes roughly 33 million pounds of paper, 65,000 gallons of ink and 1,078,000 yards of binding material just for New York City phone books, which weigh more than three and a half pounds and cost more than \$5 million per year.

In 2016, the New York State Public Service Commission granted permission to Verizon and its publisher to stop printing and delivering business telephone books to its customers, as reported by Fortune Magazine. The company printed 6.3 million business directories in the previous year. New York had given permission to Verizon in 2010 to stop delivering phone books to residential listings.

Environmental groups have joined in a national movement to reduce the publication of phone directories because of concern about the waste of natural materials and the resulting atmospheric pollution. As more people begin to rely on cellphones, whose numbers are not listed in the white pages, thousands of phone books are discarded. Microsoft News contends that 70 percent of Americans do not even open their phone books.

Environmentalists estimate that annual manufacture and distribution of telephone directories generate more than 1.4 million metric tons of greenhouse gases. Heavy ink, low-grade paper and the glued binding prevent them from disintegrating like other paper products, making them unsuitable for some recycling programs.

According to environmentalists, about five million trees are cut down each year to produce the white pages and 165,000 tons of those phone books are put in landfills. They estimate that taxpayers are spending \$17 million each year to recycle the books.

On the other hand, white page publishers emphasize that no trees are cut down to make directories; they are made from a combination of recycled paper and byproducts left over from the lumber milling process such as sawdust.

A growing number of states have adopted opt-in systems. These states include Alabama, Delaware, Florida, Georgia, Indiana, Minnesota, Missouri, New Jersey, New York, North Carolina, Ohio, Oklahoma, Pennsylvania, Texas, Virginia and Wisconsin.

Maryland is among the states that have denied requests, asking for definitive evidence that people do not use the white pages. In response, Verizon commissioned a Gallup poll, showing that household use of the white pages declined from 25 percent to only 11 percent between 2005 and 2008.

In nostalgic articles on the history of telephone directories, the Saturday Evening Post reported that Booth 17 at Grand Central Terminal was the busiest phone booth in the world, handling 50,000 calls and wearing out 100 directories annually.

The magazine also reported that during the parade on Broadway celebrating Gertrude Ederle's successful swim of the English Channel in 1926, 5,000 directories were shredded and used as confetti.


