

# ‘Pardon Our Dust:’ Resident Website to Undergo Reconstruction

Leisure World of Maryland is redesigning its resident website, (residents.lwmc.com), updating the appearance and functionality of the site to provide users with the latest community news, information and resources.

Launching in mid-September, the updated website will be similar in design and navigation to the community’s promotional website, (www.leisureworldmaryland.com), which debuted in April of this year.

“The new, secure resident website will provide information and helpful tools to residents in ways Leisure World has never seen before,” said David Merritt, resident and consultant for Leisure World of Maryland Corporation. “Over time, it will become your go-to for what’s happening in Leisure World.”

Updates to the site will occur in phases. Eventually, users will have the ability to complete a

search of current and archived documents, find contact information in an opt-in resident directory, and view a real-time calendar of events, Merritt added.

The updated site will continue to contain information important to residents, such as committee and board meeting documents, financial reports, Trust documents and Physical Properties Department service contracts.

It will also provide each user a resident login with a sign-in name and password, allowing residents to access their personal information and transactions, along with a direct link to their mutual’s website.

The updated website is being built and implemented by Frontsteps, an integrated software platform company that provides community websites for homeowners’ associations and homeowners.

Residents can visit the current website at (residents.lwmc.com), but will be redirected to the new site once it is completed.

# County Ban on Cosmetic Pesticides Overturned by Court

It’s business as usual in lawn care operations for McFall & Berry Inc., Leisure World’s landscaping contractor.

A countywide ban on the use of pesticides would have altered the company’s landscape enhancement and maintenance routine at Leisure World when it was scheduled to take effect in January 2018, but a County Circuit Court judge overturned the law Aug. 3.

Judge Terrence McGann said the law, passed by a divided County Council in 2015, was preempted by federal and Maryland state regulations that allow the use of the pesticides.

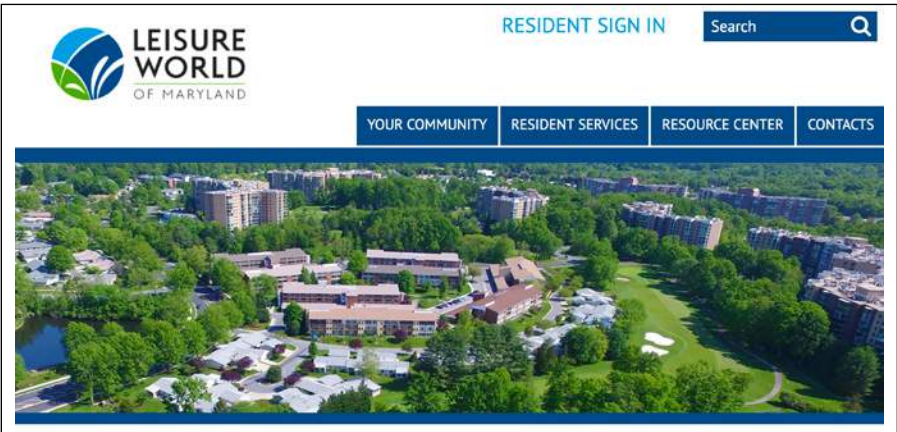
McFall & Berry Inc. offered to use as part of its services a natural or organic lawn care

program after bill 52-14 passed that would have controlled up to 60 percent of weeds. The subsequent overgrowth of crabgrass could have been combatted by other landscape operations at an additional cost, according to Michael Angles, the company’s president of operations.

Instead, the company “will continue to use traditional lawn care products at the minimal amounts needed to provide the best service possible, unless otherwise directed by the Leisure World Community Corporation board of directors,” Angles said in an emailed statement to board member Linda Wacha Aug. 9.

Although the company has tested organic pesticides and techniques at Leisure World for the last several years with

# Emergency Preparedness for Montgomery County

September is National Preparedness Month, and the Emergency Preparedness Advisory Committee marks the occasion by inviting Joseph Corona, certified emergency manager and community outreach coordinator of the Montgomery County Office of Emergency Management and Homeland Security, to discuss emergency preparedness precautions for people living in Montgomery County.

Corona's presentation includes photos and videos of extreme weather events and

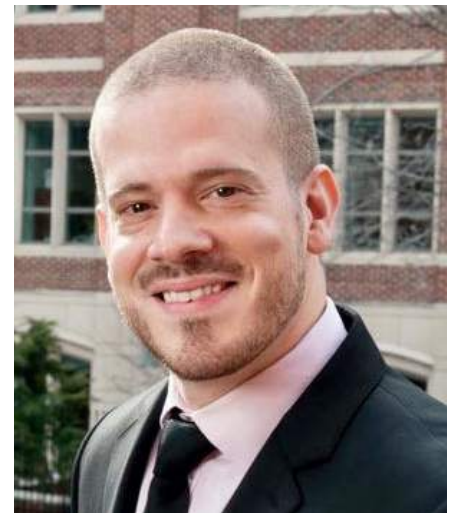
other hazardous situations that have occurred in, or around, Montgomery County.

Emergency preparedness information about newer threats, such as active shooters, is included. He also describes Montgomery County facilities available for people with special needs during emergency situations.

A basic step in emergency preparedness is to identify one's own personal support network – family members, friends, neighbors, caregivers – and develop a plan for assistance you might need from your network during, or immediately after, an emergency.

With this in mind, residents are invited to bring a family member from outside the community to this event. Remember that, for entrance into Leisure World, either the guest must have a Leisure World guest pass, or the resident must call the main gate at (301-598-1044) in advance of the event, to give the guest's name. The resident should also obtain an additional ticket for the guest.

Corona speaks on Thursday, Sept. 14, at 1 p.m. in Clubhouse I. The event is free, but tickets are required and are available beginning at 8:30 a.m. on Monday, Aug. 28, at the Clubhouse I E&R office.

reasonable success, organic products are still less effective and more costly than standard lawn care products, Angles added.

The company's use of environmentally friendly practices, such as integrated pest management, mulching and composting, and native plant selection, helps to minimize the amount of fertilizers and insecticides required to maintain the property.

The court ruling is worrisome to some local activist groups,

who argue that exposure to chemical pesticides poses a danger to human health and the environment.

If implemented, the law would have made Montgomery County the first county in the nation to restrict the use of certain pesticides on private lawns and county-owned property.

The law would have excluded agricultural land, gardens and golf courses and would not have prohibited the sale of lawn pesticides within the county.

The county has 30 days to appeal McGann's ruling.

# Third Time's the Charm

**J**ohn Gervais and Earl Hearst, no strangers to athletic competition, took home bronze medals in doubles table tennis at the Maryland Senior Olympics in Potomac, Maryland on July 29. It was the pair's third time competing together in the event.

The pair played against four other doubles pairs in a round-robin tournament. Having received just a fifth place ribbon in the same event last year, they upped their game this time around.

"I like the hand-eye coordination of hitting the ball," Gervais said. "It's a little easier on the muscles than tennis or racquetball."

The men met each other about five years ago while playing together as part of Leisure World's Ping Pong Club.

They both played the game, also known as table tennis, in their younger days, and then abandoned the hobby only to pick it up again as retired men with more time on their hands.

Gervais and Hearst agree that the sport provides more physical and mental exercise than people may realize.

"It's a lot of fun to play and you can always learn

"It's tough – maybe. We don't hold out hopes, but we always try," he said.

## Traffic Improvements in Progress at MD 97 and MD 28 Intersection

The Maryland Department of Transportation State Highway Administration (MDOT SHA) has begun a safety and traffic congestion relief improvement project at the MD 97 (Georgia Avenue) and MD 28 (Norbeck Road) intersection.

Crews will work on the project by removing the median islands at the intersection, and clearing trees and vegetation necessary to construct stormwater facilities later in the project.

Mature trees removed as part of the project will be replaced by smaller saplings of a similar species in or near the work zone once the project is complete.

Once clearing is complete in September, construction will include an additional left-turn lane on northbound MD 97 approaching MD 28 and beginning approximately 900 feet south of MD 28, extending north for one-fifth of a mile.

A right-turn lane will be constructed on westbound MD 28 approaching MD 97 at the Park and Ride lot entrance, extending west for a distance of one-sixth of a mile.

Work crews will widen MD

28 and MD 97 to accommodate the new turn lanes. Additional construction includes:

- a concrete median on MD 97;
- new curbs and sidewalks along westbound MD 97;
- upgrading of curb ramps and sidewalks in compliance with the Americans with Disabilities Act;
- removing a small section of the Park and Ride lot to accommodate the intersection changes and repaving the lot; and
- reconstructing the intersection's traffic signal with new mast arms, signal heads and brighter LED lamps.

To perform all phases of work, crews are permitted to close one lane in both directions of MD 28 or MD 97, on weekdays from 9 a.m.-4 p.m. and two lanes, overnight, Sunday through Thursday, from 9 p.m.-6 a.m. MDOT SHA recommends drivers plan for extra travel time during construction.

Pedestrian traffic will be maintained during all times during the project. Sidewalk users may be directed to alternate safe crossings within the work zone, including the opposite side of the street.

## Shredding Availability

Management has contracted with the Shred-It Company to provide residents with a safe and secure manner by which they may have their personal documents destroyed. This service is available on site, free of charge, on a regular basis.

Secure, locked consoles are located in the lobbies of the Administration Building, both clubhouses and PPD. The consoles are capable of accepting up to 400 pieces of paper at a time. Once papers are deposited in the console, they fall into a blue bag, which cannot be removed except by unlocking the console.

Twice a week, a Shred-It representative picks up the blue bags from inside the consoles, seals them and transports them to a mobile shredding truck in the Leisure World parking lot. The bags are emptied behind a locked security screen into a shredding hopper, which shreds everything into fine confetti.

Please note that staples, paper clips, and binder clips do not need to be removed. However, please do not bring items that go in your regular recycling, such as envelopes, newspapers and magazines.

## More about CCOC Training and Test

The writer of the July 21 Thoughts & Opinions submission entitled “CCOC Training Not So Good” did the community a service. He listed many of the errors in our county’s Commission on Common Ownership Communities (CCOC) training and test, which is currently required of all Leisure World board members and all mutual board members.

The problems he cited are among several that were discussed openly for months in the Leisure World Government Affairs Advisory Committee’s (GAAC) review of the Montgomery County Council’s efforts to initiate and require such a test. By happenstance, a number of GAAC members had careers in education, and so were uniquely qualified to monitor the proposals and predict the outcome. For example, I myself had been a test writer and administrator of international professional certification tests.

Apart from the recognized

faulty content and administration of the CCOC test, two additional important issues are the high cost of developing the test and the severe penalties that could be imposed for failure to successfully complete the test.

In terms of cost, the original estimate was \$30,000 but, according to televised testimony, the CCOC seemed to offer the University of Maryland an open-ended budget. I wish I knew what the final figure turned out to be.

Failure to comply by not passing the test is a “Class A” civil violation, which could carry a fine of up to \$750 for each offense! The CCOC has stated that it does not intend to actually impose this penalty. So, why is it on the books? And, although it did not follow through on this, I heard that the CCOC once considered a penalty of removing a board member from office. I think that is outrageous!

I believe that board members should know as much as possible about their positions and the law, regulations, and best practices that apply to common ownership communities. However, requiring them—under penalty

of law—to learn inaccurate information, at great public cost, serves no one!

## Independent Analysis Needed

I think it is time for a clarification of the actual information and necessity for the destruction of the current administration building and the construction of a new one.

After listening to both sides and seeing very intolerant emails circulated with disparaging and insulting comments, I feel that it is time for all to step back and reconsider their positions. With the amount of information and misinformation and the high and righteous positions taken by some, it is time for an independent investigation and analysis of the entire matter.

With my background as a management and engineering consultant working with an excellent group of highly educated and experienced co-workers, it has been my experience that we were asked many times to be an independent observer and analyst of the management and functioning of a firm. Our business was to study the organization and its operations from a number of strategic planning concerns and analyze the ability to meet expected growth. Then, we would give our opinion as to whether the basis for the plans would be met and recommend actions to be taken to achieve those goals.

That is exactly what is needed in this situation. It is not something that will be accomplished within the community whether by management or the board of directors. An unbiased,

knowledgeable assessment has to be made and the validity of the claims on both sides must be addressed.

This fear of outside “intervention” is not realistic. In many cases only competent consultants, without any connection to our management or board, will review the details and plans and come up with a valid assessment.

In other words, let us be respectful of the rights of all residents and not be taken for fools or addressed in that manner.

As part of this, each representative to the board should be holding a meeting of the residents in their respective mutual and bringing the voice of the community to the table. Then, have the outside experts analyze the plans and tell us the truth.

## Mutual Boards are the Only Way

Last month’s town hall meeting demonstrated that a significant number of residents are opposed to current plans for a new Administration Building. I believe that the only effective way to bring about change in Leisure World (LW) is through its established structure. Our governing documents indicate that the mutuals are responsible for “the Trust.”

Changing LW board decisions requires that mutual boards be convinced first. Mutual boards have the authority to designate their representative to the LW board (no expensive, lengthy, messy challenge to our established governing structure will change that in our lifetimes). The correct pathway to changing current plans is through mutual boards.

They must attend mutual board meetings and make their case. They must insist that their mutual board direct their LW board member to represent their views. If necessary, they must educate and influence the residents in their mutual to communicate their views to their mutual board members. If necessary, residents must step forward responsibly to elect mutual board members who reflect their views.

Who, among the 300, has done these things? No other action will bring about change. As Pogo said, "We have met the enemy and they are us!"

I have the feeling that many of us aren't aware that we have this right to quiet enjoyment of our

premises. In my opinion, it's right up there with freedom of religion and freedom of speech. After all, "a man's home is his castle." Indeed, it is our government's job, but also that of one another, to enforce this law, so that we can live peacefully and healthfully together.

# Sept. 10: Human Evolution and Our Changing World

On Sunday, Sept. 10, Fred Edwords of the American Humanist Association, and in association with the Smithsonian National Museum of Natural History, expounds on “How Human Evolution is Changing Our World Now.”

The study of human evolution can tell us who we are today and who we may be tomorrow. The most telling discovery is that humanity’s impact on planet Earth has become so great that it is reflected in the fossil record, which is why scientists are calling the present epoch, the Anthropocene, the “Age of Humans.”

How did this happen and what does this tell us about human nature and the future of our species? And what should be our response?

Fred Edwords has been executive director of the American Humanist Association, editor of the Humanist magazine, and national

director of the United Coalition of Reason. As a continuing voice for humanist ideas over the past 40 years, he has appeared on national and local radio and television and has lectured in North

America, Europe and India.

Edwards is an adjunct faculty member of the Humanist Institute, is the historian of the American Humanist Association, and is a member of the Broader Social

Impacts Committee (BSIC) of Smithsonian’s Human Origins Initiative at the National Museum of Natural History.

He is also director of planned giving for the Humanist Foundation of the American Humanist Association.

Although FISH suggests loaning an item for one to three months, shorter loans are also encouraged. Why rent if you can borrow for free? A short-term loan is returned to FISH and available sooner for other users.

An item may also be kept longer than three months, or borrowed on behalf of the needs of a friend or visitor.

"FISH" stands for "Friends in Sickness and Health." Many service-oriented FISH organizations exist around the world, each with its own mission.

# Town Hall Turnout Fuels Debate on Building

An overwhelming community response to a town hall meeting on plans for a new Administration Building has boosted momentum for the effort to have those plans shelved, say leading opponents of the project.

"It's not a done deal," declared Sheryl Katzman, president of JustUs, a residents advocacy organization that launched the town hall last month.

Instead, about 300 residents made their way through pouring rain to attend the July 28 event in the Crystal Ballroom of Clubhouse I, and they heard top opponents describe steps they still can take to stop the estimated \$5.2 million undertaking.

"I gained a deepened level of respect for this community," said Marybeth Ardike, after witnessing the sizable turnout. She is president emeritus of Leisure World Green, an environmental group, which teamed with JustUs to conduct the town hall. Also guiding the event were LW Green co-presidents Janice McLean and Elaine Hurley.

LW Green opposes the project primarily because it would result in the destruction of nearly 60 trees and other plant life, and the group believes it would create a heavy environmental burden with demolition of the existing 50-year-old Administration Building.

The new building would be located just north of Clubhouse I. The existing Administration Building site would become a parking lot. More than 80 new trees would be planted but won't mature for 15 years or more, Ardike noted.

Opponents want a study done of the old building to see if it could be updated to better accommodate administration staff and meet current codes. They also have sought a community referendum on the project, but the community's board of directors soundly defeated that request in May.

Now opponents are urging residents to focus on the Maryland-National Capital Park and Planning Commission, where the plans have been sent for

consideration. The Commission is scheduled to hold a hearing Nov. 2.

LW Green and JustUs handed out at the town hall an information sheet describing how residents can influence the Commission's decision. (Details can be found at the Leisure World Green of Maryland Facebook page.)

At the town hall, one of the first residents to approach an audience microphone during the comment period said he appreciated LW Green's concerns, but for him, and many others, the principal issue is the financial cost of the project. Another said opponents should get a lawyer and seek a court injunction.

Ultimately about 20 residents went to the microphones to comment on the project, give reasons for opposition and make

suggestions for increasing opposition. One resident read a statement in support of the project.

Katzman said there will be more town hall-style meetings in the near future so that residents can learn more about and comment on other important community issues, especially

how Leisure World is governed.

The town hall on the Administration Building attracted the attention of media outside of Leisure World. Reports on the controversy have appeared in the Sentinel newspaper, the Greater Olney News and on WJLA television.

## ■ Ceramics Club

# Glaze, a Necessity for Earthenware

In the ceramics studio, we make earthenware pottery. The clay begins as a liquid called slip. Once formed, cleaned and dried, it is fired at a relatively low temperature, about 1,850 degrees Fahrenheit.

Low fire is best for bright colors and detailed decorations, but the pieces are not fully vitrified (i.e. the clay is not fully fused); it is still quite strong, but a glaze must be applied to make the piece waterproof.

If decorations have been painted on the piece, a clear glaze is applied. For other pieces, there are many glaze colors and color combinations to choose from, as well as glazes with crystals that burst into color when fired in the kiln.

The glazes can be applied alone or in combination with other glazes. The glazes at Leisure World are always brushed on, unlike at the paint-your-own-pottery places, where pieces are dipped into a bucket of glaze.

When applied with another glaze, a cascade glaze makes the colors flow together. Ceramicists can get amazing, and sometimes surprising, results.

We have a saying in the

studio, "You never know exactly what your piece will look like until it completes its final firing in the kiln."

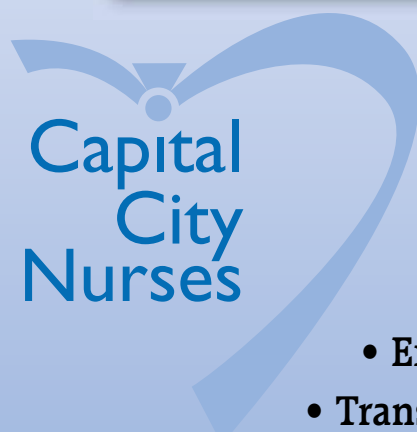

## FY 2018 Proposals



The Republican Study Committee is the latest group to offer its proposals for FY 2018 for reducing federal employee pay and benefits.

The committee also recommends Congress transition the Federal Employee Health Benefits Program (FEHBP) to a “premium support system.”

It suggests that because government covers a set percentage of an employee’s health premium, FEHBP participants have an incentive to choose higher-priced health plans.

In discussing these issues, the executive board noted that any reductions that might be passed for current employees might be used as justification for reducing the benefits for current retirees.

# Are You Getting All the Security Updates?

**K**eeping all software up-to-date is important, but what is the best way to ensure that you are getting all of those macOS updates?

The primary consideration for updates is to keep your Operating System (OS) up-to-date. The OS is your first line of defense from internet malware. To make the process simple, Apple has provided a way to make it relatively automatic.

Go to System Preferences and select the App Store. At the top is the selection, "Automatically check for updates." Check that box. The selections below that modify the automatic action and should all be checked in most cases.

The first, "Download newly available updates in the background" should always be checked. The next two, "Install app updates" and "Install macOS updates" will, when checked, install the updates automatically.

If they are left unchecked, users are notified of updates and given the opportunity to install them manually in the future. The last option is very important. If a user fails to check the last option, "Install system data files and security updates" they won't be notified of critical background security-related updates.

These security-related updates are the things that typically accompany the "point" updates that occur between the major OS updates, and are the very ones that you should be vigilant about downloading and installing.

In the box below those selections, users see an annotation that declares when the last update check was made. The button to the right lets users do another check that instant.

While the App Store Preference page is open, it's a good time to review the remaining

selections on Password Settings. To be able to change the settings, users must do two things: (1) Unlock the page by clicking on the lock in the lower left corner and entering the computer's Admin login and password; (2) Launch the App Store application and login to it by selecting Store > Sign In.

Now the settings' menus become enabled.

The selection for purchases allows users to either keep their App Store password active for 15 minutes after they have signed in, or requires an App Store password for each purchase. The Free Downloads selection

allows users to either use their on-file App Store password or forces them to re-enter it for all free downloads.

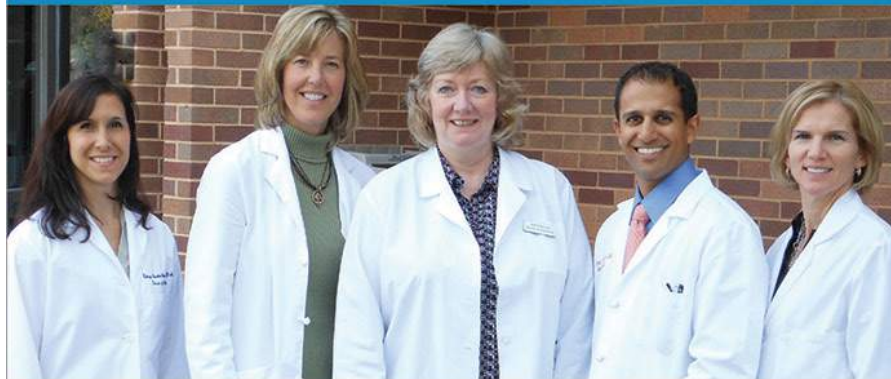

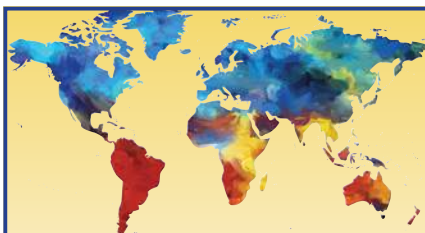

# Surveying Land and the Chess Board

by Bernie Ascher

Two men worked methodically for five years to create the Mason-Dixon line, setting the border between Maryland and Pennsylvania. The line, perhaps the most famous boundary in the U.S. and subsequently a symbolic separation between “free states” and “slave states,” is named after the men who created it.

A remarkable technical accomplishment for its time, the job probably could have been completed in five seconds with today’s technology. If only they could have waited for the Global Positioning System (GPS) and Google Maps.

But at the time, local surveyors and government officials had no such help.

After the surveyors failed to draw the line, and with a pressing need for a survey to resolve an 80-year old dispute between the two colonies, Thomas Penn and Frederick Calvert (also known as Lord Baltimore) asked the Royal Society in England for help.

The society recommended Charles Mason (an astronomer) and Jeremiah Dixon (a surveyor) for the job. In November 1763, they left Britain and arrived in Philadelphia with many tools and equipment, including: a zenith sector; a set of star tables prepared by the Royal Observatory; and 200 stone pillars, each weighing at least 400 pounds, to be used as mileage markers.

The zenith sector, a very accurate six-foot telescope, one-quarter of the size of the Observatory’s instrument, was built especially for the task.

In Philadelphia, they added a specially made pendulum clock to time their astronomical observations. They would make multiple observations of five different stars to determine the latitude, then travel West to find another point with exactly the same latitude. This would continue for five years, marking individual points and surveying to mark straight lines between them.

With all the equipment they hauled, it was clear they could not do the job alone. In those days before interstate highways and roadside motels, they needed help – guides, horses, wagons, and workers to clear trees and foliage and to move the heavy stone markers. They needed interpreters to communicate with Native Americans.

They cut a 24-foot-wide path through the dense woods, the mountains and valleys. Every mile was marked by stones and by crown stones every five miles. They crossed rivers and moved West about two miles a day, along with as many as 120 people at a time,

including 40 ax men, a herd of sheep and a milkmaid.

Mason and Dixon completed their work in October 1767, having surveyed 233 miles, ending just northwest of Oakland, Maryland. They installed 133 stone markers along the line, many of which were lost over time. Ironically, GPS technology was used later to find the lost stones.

Geography is no obstacle to chess. It can be played north or south of the Mason-Dixon Line. In the illustrated game on this page, White has an advantage in manpower, how can it best be used?

The answer will follow our reminder that the Chess Club meets on Monday, Wednesday and Friday from 1-4 p.m. in Clubhouse II. Membership is free. For further information, call President Bernie Ascher at (301-598-8577).

ANSWER: White’s Rook at c1 captures the Black Pawn at c6. Black’s Bishop captures the Rook. White’s Queen then



captures the Bishop. Black’s King can move to b8 or d8. Either way, White moves the Rook to a8. Checkmate!

So, do not wait for further measurements. Do not wait for more milestone markers. Do not wait for technological advancements. Play chess now!
